The Hinds County Economic Development Authority will receive bids for the Clearing and Grubbing of Lot 1, Wynndale Industrial Center no later than 2:00 P.M., Local Time, on September 18, 2017, at 125 South Congress Street, Suite 1500, Jackson, MS 39201. All bids so received will be publicly opened and read aloud. The work shall consist essentially of the following items:

Installation of a concrete culvert for construction access, erosion control and clearing and grubbing of 58.2 acres on Lot 1 in the Wynndale Industrial Center. This is to include all other related items of work required to complete the project as shown and specified in the Contract Documents.

The above general outline of features of the work does not in any way limit the responsibility of the Contractor to perform all work and furnish all parts, labor, equipment and materials required by the specifications and the drawings referred to therein.

An optional Pre Bid Conference will be held at 10:00 A.M. Local Time, on Wednesday, September 6, 2017, at the offices of Waggoner Engineering located at 143-A LeFleur's Square, Jackson, Mississippi 39211.

The Hinds County Economic Development Authority hereby notifies all Bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, disadvantaged and women's business enterprises will be afforded the full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award.

2. Waggoner Engineering Inc. located at 143-A LeFleurs Square, Jackson, Mississippi, 39211. All documents required for bidding purposes may be obtained from Waggoner Engineering, Inc. upon payment of \$100.00 for each set which will not be refunded.

Each bid shall be accompanied by a Certified Check on a solvent bank or a Bidder's Bond issued by a Surety Company licensed to operate in the State of Mississippi, in the amount of five percent (5%) of the total bid price, payable to the Hinds County Economic Development Authority as bid security. Bidders shall also submit a current financial statement, if requested by the Authority. The successful bidder will be required to furnish a Performance Bond and a Payment Bond each in the amount of one hundred percent (100%) of the contract amount.

The proposal and contract documents in its entirety shall be submitted in a sealed envelope and deposited with The Hinds County Economic Development Authority, 125 South Congress Street, Suite 1500, Jackson, Mississippi 39201 prior to the hour and date above designated. No bidder may withdraw his bid within sixty (60) days after the date of actual bid opening, without Owner's consent.

Work to be performed shall be in accordance with the "Mississippi State Highway Standard Specifications for Road and Bridge Construction, 2004", together with all amendments and/or special provisions and/or addenda to the standards duly approved and adopted, unless otherwise noted in these specifications.

The attention of Bidders is directed to the provisions of Subsection 102.07 pertaining to irregular proposals and rejection of bids.
