# Summary of work:

Generally, the Scope of Work consists of the following:

## **BID PACKAGES**

<u>Bid Package #3 - Cut/Fill (Muck Out, Fill and Structural Pads):</u> Excavation of unsuitable soils and replacement with structural fill material, placement of structural fill pads at new building locations and select areas on site as required.

<u>Bid Package #6 – General Works Package:</u> Provide, installation and administration of temporary facilities, safety requirements, temporary protection, erosion control, miscellaneous wood blocking and carpentry, temporary clean-up, final clean-up, temporary roads and access, selective demolition, miscellaneous utility connections, and other miscellaneous work items required to complete the project scope.

<u>Bid Package #7 – Concrete & Reinforcing Steel:</u> Installation including formwork and placement of the following; Soil Treatment, Concrete Foundations, Concrete Flatwork, Vertical and Elevated Concrete, and Reinforcing Steel at Concrete locations. This package 'EXCLUDES' the Reinforcing Steel Material, but includes all labor and items required to provide a complete Concrete & Reinforcing Steel system.

<u>Bid Package #8 – Masonry:</u> Installation of all Masonry units including CMU, Face Brick and Cast Stone, and Reinforcing Steel at Masonry locations, placement of all Concrete Fill material, and Block-Outs in Masonry walls as required. This package 'EXCLUDES' the Reinforcing Steel Material, but includes all labor and items required to provide a complete Masonry system.

<u>Bid Package #9 – Structural Steel:</u> Installation of the Structural Steel package including all miscellaneous steel items identified in Division-5 Metals. This package 'EXCLUDES' the Structural Steel Material, but includes all labor and items required to provide a complete Structural Steel system.

<u>Bid Package #13 – Doors, Hardware & Openings:</u> Provide labor, material and supervision for the complete Door, Hardware & Openings package including Hollow Metal, Wood, Special Door Openings, Coiling Doors and Hardware required.

<u>Bid Package #23 – Elevators:</u> Provide labor, material and supervision for the complete Elevator package including Cab Finishes as required.

<u>Bid Package #24 – Fire Sprinklers:</u> Provide labor, material and supervision for the complete Fire Sprinkler package including Design Drawings and Certification as required.

<u>Bid Package #28 – Electrical:</u> Provide labor, material and supervision for the complete Electrical package as required. This package 'EXCLUDES' the Switchgear, Panels, and Light Fixture Material, but includes all labor and items required to provide a complete Electrical system.

<u>Bid Package #30 – Materials & Testing:</u> Provide labor, material, supervision and certification of Materials & Testing as required for soil, concrete, structural steel, and miscellaneous items as required.

<u>Bid Package #31 – Labor Unit Prices:</u> Provide unit prices for labor associated with 'ALL' Bid Packages as listed above.

Strict conformance to Educational K-12 guidelines, construction noise abatement, and ability to organize work with flexible hours and manage disruption during the continuity of work is vital to the successful completion of the project.

Bidders shall have proven and demonstrated ability to construct and renovate fully operational K-12 Educational Facilities in a K-12 or other Educational facility within the last five years. Contractors and Subcontractors with experience at the Gulfport School District in Harrison County are encouraged to respond to this solicitation; however, the Gulfport School District will take into consideration all bidders who have demonstrated acceptable qualifications.

Work shall be completed as indicated on the individual Bid Forms (see Division 00 Section 00 41 13 – Bid Form – and – Section 00 41 63 – Direct Purchase Program) Liquidated damages shall apply for non-compliance.
