#### I. INTRODUCTION

Gulf Coast Renaissance Corporation ("Renaissance") a non-profit lender in Gulfport, MS, is requesting proposals from qualified construction firms or individuals who wish to provide residential repair and construction services to homeowners for the purpose of repair/retrofit for mitigation and fortification of single family homes. Renaissance will maintain a list of approved contractors for the Ready Loan Fund program.

#### II. DESCRIPTION OF COMPANY

Renaissance, incorporated in 2007, has a staff of 13 people. Renaissance is seeking residential contractors to perform home repair/retrofit and fortification work on homes through the Ready Loan Fund. The Ready Loan Fund will provide loans to low to moderate income households for the purpose of repair/retrofit/rehab of existing primary residences, roof fortification for insurance cost reductions, energy efficiency upgrades, and/or upgrades for handicap/elderly accessibility.

#### III. SCOPE OF SERVICES

Renaissance requests a statement of qualifications from firms/individuals to perform the following services.

- A. Work with individual homeowners as well as the Gulf Coast Community Design Studio (GCCDS) to determine scope of work;
- B. Provide a cost estimate based on defined scope of work;
- C. Make repairs/retrofits as detailed in the scope of work;
- D. Complete roof retrofit work according to FORTIFIED home requirements set forth by the Institute for Business & Home Safety (IBHS) to achieve Bronze certification, when applicable.
- E. Work with GCCDS and FORTIFIED Evaluators, where applicable, on inspections including final inspection of work performed and completed.

#### V. RESPONSE REQUIREMENTS

The following material is required to be received for a responding firm to be considered:

- A. Cover Letter/Title Page to include name of firm/individual, address, phone number and email address of the contact person, the date of the response and a table of contents.
- B. Company Background brief description, history, number of employees, years of experience, etc.
- C. Detailed Qualifications and Experience
  - 1. All applicants should state experience in providing residential repair/construction services, with a special emphasis on energy efficiency upgrades and roof retrofits certified through the FORTIFIED Program.
  - 2. If applicant is a firm as opposed to an individual, identify the manager in-charge who will be assigned to our job, and provide resume of past work.
  - 2. All insurance with a minimum of the following:
    - a. Comprehensive General liability: \$1,000,000 per occurrence
    - b. Workers' compensation: \$100,000 per occurrence
  - 3. Referral of at least (3) individuals/companies for which work has been completed, including type of work and dates.

#### V. EVALUATION CRITERIA

- A. **Qualifications** Documentation reflecting the qualifications of each person who will be providing the service. Maximum 30 Points
- B. **Experience** Documentation regarding the experience of the firm. This should include types of projects undertaken. Maximum 45 Points
- C. Capacity for Performance Description of the firm's work force including the number and title of staff available to provide requested services. Maximum 25 Points
