Each switch must have the capabilities to be Core Switches and compatible with existing switches of the West Point Consolidated School District which include but not limited to Cisco 2950G-3750G and **support OSPF**. All switches must be capable of 1 GB port speeds and interfaces between switches of 10 GB. In addition, the vendor must provide the following:

- Warranty Information on Replacement
- Annual Cost of Maintenance if needed
- Vendor's Distance from District in regards to Repair and Support
- Separate equipment and configuration cost for additional parts to establish function for the switches.
- Options for the following:
 - Include Switch Configuration as an optional cost
 - Include Switch Installation as an optional cost
 - Include 5 year Software support (Smartnet) as an optional cost

The quotes must be in 2 sections which clearly identify Erate Eligible equipment/Software/Etc. in one section and Non-Erate Eligible Equipment/Software/Etc. in another section.
