Access Points

- Must support 2.4GHz and 5GHz
- Must use enterprise-class radios for maximum RF performance and coverage
- Must support rogue access point detection and denial of service attack protection
- Must support coverage for 802.11b/g/n/ac clients

- Must support client load-balancing across frequencies in mixed client environments
- Must support multicast video delivery across WLAN
- Must support radio resource monitoring, dynamic channel assignment, interference detection
- Must have on-site controller, no cloud base

Vendor Cabling

- Any cables run by the vendor will be terminated into a patch panel on one end and into the Access Point.
- The District will help to reorganize racks at each site if needed.
- Vendor may use any available open port on any switch currently in use in the district.

Configuration of Devices

The District will handle all configurations of all access points, controllers, and etc.

E-Rate

This proposal request is for services to be subsidized under the Universal Services E-Rate Program for Schools and Libraries. No purchase order will be issued, no installation will occur and no services will be provided until approval of the form 471 application that is issued as a result of the proposals being submitted in response to this request.

Right to Reject

The Leland School District reserves the right to accept or reject all proposals or sections thereof when the rejection is in the best interest of the school system. The Leland School District reserves the right to award without further discussion. Therefore, responses should be submitted initially with the most favorable terms that the vendor proposes. The Leland School District reserves the right to reject the proposal of a vendor who has previously failed to perform properly or completed on time contracts and to reject the proposal of any vendor who in the opinion of the Leland School District Board of Trustees, is not in a position to adequately perform the contract. The Leland School District Board of Trustees reserves the right to Request for Proposals reject any and all proposals, any part or parts of a proposal, waive any technicalities/informalities, increase or reduce quantities, make modifications or specifications, and award any or the entire contract in a manner that is in the best interest of the Leland School District. Contracts will be awarded to the vendor submitting the proposal determined to be in the best interests of the Leland School District.

Disqualification of Bidder

The Leland School District reserves the right to award to other than the lower bidder when, in the judgment of the district administration, it is in the best interest of the district to do so. A Bidder may be disqualified for such reasons as:

- Bidder's failure to comply with requirements regarding Certificate of Responsibility.
- Bidder's failure to attend and complete the mandatory Pre-bid walkthrough.
- Bidder being in litigation with the Leland School District.
- Bidder having defaulted on a previous contract.
- Bidder having performed unsatisfactorily on a previous contract
- Bidder's failure to fulfill the warranty obligations of a previous contract with the Attala County School District.
- Bidder's failure to include documentation for required certifications and authorizations.
