#### **Project Details**

1. Describe the commodity that the agency is seeking to procure: The University of Mississippi Medical Center (UMMC) seeks to purchase the AirSeal system from ConMed for use in laparoscopic and robotic cases.

The AirSeal system consists of a trocar, tubing and filter set and a re-circulation and filtration control unit that is used to create and maintain a port of entry during laparoscopic and robotic procedures. This system functions to create an AirSeal to maintain pneumoperitoneum, constant smoke evacuation and valve-free access to the abdomen during the surgical procedure. The abdomen is inflated with CO2 for a laparoscopic and robotic procedures and if there is leakage of this pressure, the abdomen can deflate. This deflation, or loss of pneumoperitoneum, increases the risk of injury to the patient, in addition to increasing the overall length of the procedure. This system is able to provide a lower pressure overall to maintain the pneumoperitoneum which decreases post-operative pain, thereby decreasing narcotic use and recovery time for the patient.

# 2. Explain why the commodity is the only one (1) that can meet the needs of the agency:

The AirSeal system is a one of a kind system. Currently, items from various vendors are used in these procedures and patients incur higher abdominal pressures in the attempt to keep the abdomen inflated. Studies have proven this all in one system functions to provide a stable pneumoperitoneum at lower pressures, which decreases CO2 gas absorption as well as pain and recovery time for the patient, in addition to decreasing OR time.

## 3. Explain why the source is the only person or entity that can provide the required commodity:

ConMed manufactures the AirSeal system and the proprietary components and disposables for proper use of the system. ConMed is the sole manufacturer and supplier of the AirSeal system. They are not available from any other distributor. See supporting letters from ConMed. Attachment A.

# 4. Explain why the amount to be expended for the commodity is reasonable:

The estimated amount to be expended annually for the purchase of the **AirSeal System** is \$200,000. This amount is within the expected price range for these products.

# 5. Describe the efforts that the agency went through to obtain the best possible price for the commodity:

Through market intelligence, UMMC was able to negotiate best pricing for these products. All applicable discounts were explored and applied.
