## **ADVERTISEMENT FOR BIDS**

Sealed bids for the construction of the **Martin Street Utility Upgrades** project will be received by the City of Pascagoula, at the Pascagoula City Hall, 603 Watts Avenue, Pascagoula, MS 39567 until 2:00 p.m., Local Time, July 12, 2017, at which time the Bids received will be publicly opened and read.

The project consists of replacing and upgrading water and sewer utilities in the area of Martin Street and Ingalls Avenue. Specifically, the project requires replacement of more than 800 linear feet of 8" and 12" gravity sewer; 1,500 linear feet of 8" sewer force main; replacement of 1,500 linear feet of 2" gas main and 2,300 linear feet of 8" and 12" water main. In addition to the utility line replacement, the project will require repairing concrete and asphalt streets, traffic control, and other related construction activities.

Bids will be received from a single prime Contractor. Bids shall be on a unit price basis, with additive alternate bid items, if applicable, as indicated on the Bid Form.

All bids shall be submitted in a sealed envelope addressed to the City Clerk of Pascagoula. If a bid is submitted by mail, the post office address of the City Clerk is P.O. Drawer 908, Pascagoula, Mississippi 39568-0908.

All bid envelopes should contain the bidder's name and mailing address on the face of the envelope and shall specify the name of the bid package.

Contract documents are being made available via paper copy or pdf for a charge of \$100.00 (hard copy) or \$50.00 (CD). Plan holders are required to log-in or register for an account at <u>www.bmaprojects.com</u> to view and order Contract Documents. All plan holders are required to have a valid email address for registration. The cost for the Contract Documents is non-refundable and must be purchased through the website. The date that the Contract Documents are transmitted by the Issuing Office will be considered prospective Bidder's date of receipt of the Contract Documents. Partial sets of Contract Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be

responsible for full or partial sets of Contract Documents, including Addenda, if any, obtained from sources other than the Issuing Office.

Each bid shall be accompanied by a Certified Check on a solvent bank or a Bidder's Bond issued by a Surety Company licensed to operate in the State of Mississippi, in the amount of five percent (5%) of the total bid price, payable to the City of Pascagoula, as bid security. Bidders shall also submit a current financial statement, if requested by the City of Pascagoula. The successful bidder will be required to furnish a Performance Bond and a Payment Bond each in the amount of 100 hundred percent (100%) of the Contract amount.

For bids exceeding \$50,000.00, Bidder must indicate his <u>Certificate of Responsibility Number</u> on the outside of sealed proposal as required by Mississippi Law. Effective July 1, 2010; per MS Code 31-3-21(3); any bid submitted by a nonresident contractor which does not include the nonresident contractor's current state law pertaining to such state's treatment of nonresident contractors, shall be rejected and not considered for award. If no such law exists in the nonresident contractor's state, then the non-resident contract may provide a statement to that effect.

No bidder may withdraw his bid within sixty (60) days after the actual date of the opening thereof.

The Owner reserves the right to waive any informalities or to reject any or all bids.
