A pre-bid conference will not be held.

All bids submitted in excess of \$50,000 by a contractor to do erection, building, construction, repair, maintenance, or related work, on public projects must comply with Section 31-3-21, Mississippi Code of 1972, and must have a "Certificate of Responsibility" number. Where applicable, the foregoing certificate number must be indicated on the exterior of the sealed bid envelope before it can be opened.

All local, state, and federal special conditions will apply. Section 3 of the Housing and Urban Development Act of 1968 requires that the county, water association, and contractors participating in CDBG projects give opportunities for job training and employment to lower income residents of the Section 3 area that is described as Montgomery County, Mississippi. Section 3 also requires that to the maximum extent feasible contracts for work in connection with Section 3 covered projects be awarded to businesses that are located in or owned by Section 3 persons residing in the Section 3 area.
