Sealed bids will be received by the **Natchez Water Works Board of Water Commissioners of the City of Natchez, office of Natchez Water Works, 150 North Shields Lane, Natchez, Mississippi**, until **4:00 p.m. on January 20, 2015**, and shortly thereafter shall be publicly opened and read at a meeting of the **Natchez Water Works Board of Water Commissioners, 150 North Shields Lane, Natchez, Mississippi**, for **PROJECT NO. 022-13-WW, HIGHLAND BOULEVARD SURCHARGE BYPASS LIFT STATION**, in the City of Natchez, Mississippi.

Plans, specifications, and contract documents may be examined without charge in the office of the Natchez City Engineer, 150 B. North Shields Lane, Natchez, Mississippi 39120, Phone: 601-445-7520, or obtained from said office for a charge of **\$100.00**, not refundable, which partially covers the cost of reproduction and handling.

1. **DESCRIPTION OF WORK:** This work covers the materials, equipment, construction, and application procedures for installation of a Gravity Sanitary Sewage Transmission Main and Sanitary Sewer Force Main as directed by the Engineer.

3. The sewage collection system installation shall consist of approximately 6,200 linear feet of twenty-four inch gravity sewer pipe and a wet well for the pump station. Most of the collection pipe will be PVC SDR 26, except in areas depicted on the plans where it shall be ductile iron.
- 4.
5. The force main installation shall consist of approximately 1900 linear feet of fourteen inch polyethylene and ductile iron pipe and completion of the pump station including triplex submersible sewage pumps, valves, internal and external piping, electrical and control system and top grate.

A certified check or bid bond for **5%** of the total bid, payable to the Natchez Water Works, Natchez, Mississippi, must accompany each proposal. Bidders are hereby notified that any proposal accompanied by letters qualifying in any manner, the condition under which the proposals are tendered, will be considered an irregular bid and such proposals will not be considered in making the award.

The award, if made, will be made to the lowest and best bidder on the basis of the published quantities, who is considered qualified by the board. The board reserves the right to waive informalities and to reject any and all bids.
