Separate sealed bids for C.D.B.G. Project No. 1130-13-135-ED-01, East Stonewall Road, Byhalia, Mississippi will be received by the Town of Byhalia in the Byhalia Town Hall on May 19, 2015, until 5:30 PM Local Time, at which time and place all Bids will be publicly opened and read aloud.

Each bid must be submitted in a sealed envelope addressed to the Town of Byhalia. Each sealed envelope containing a bid must be plainly marked on the outside as "Bid for C.D.B.G. Project No. 1130-13-135-ED-01, East Stonewall Road, Byhalia, Mississippi." Any bid for a sum in excess of \$50,000.00 shall contain on the outside or exterior of the envelope of such bid the contractor's current certificate of responsibility number, and no bid shall be opened or considered unless such contractor's current certificate number appears on the outside or exterior of the envelope or unless there appears a statement on the outside or exterior of such envelope to the effect that the bid enclosed does not exceed \$50,000.00.

The work is as follows:

Approximately 0.7 miles of grade, drain, base and paving, gas and water relocation.

A certified check or bank draft, payable to the order of the Town of Byhalia, negotiable U.S. Government bonds (at par value), or a satisfactory Bid Bond executed by the Bidder and an accepted Surety, in an amount equal to five percent (5%) of the total of the Bid shall be submitted with each bid.

Attention is called to the fact that not less than the minimum salaries and wages set forth in the Contract Documents must be paid on this project, and that the Contractor must ensure that employees and applicants for employment are not discriminated against because of their race, color, religion, sex or natural origin. All bidders will abide by the Federal Housing and Urban Development's Section 3 Regulations (24 CFR 135).

This project is financed by a Community Development Block Grant and is subject to the rules and regulations thereof.

The Town of Byhalia reserves the right to reject any or all Bids or to waive any informalities in the bidding.

Bids may be held by the Town of Byhalia for a period not to exceed 90 days from the date of the opening of Bids for the purpose of reviewing the bids and investigating the qualifications of Bidders, prior to awarding of the Contract.
