## REQUEST FOR BIDS ON STEEL BOLTED/NON WELDED BUILDING

- -Building dimensions: Width 30'-0"; Length 80'-0"; Eave Height 10'-0" Roof Slope 1:12
- -Roof type to be gable and will be clear span
- -Side wall columns are to be straight columns with flush girts
- -Roof bracing to be cable type
- -Building to have a center transverse floor to roof partition wall. Partition wall to be insulated and sheeted both side floor to roof
- -Center partition wall will make two (2) 30' x 40' rooms
- -Four (4) 3'-0" x 7'-0" metal walk doors with lock sets and necessary weather striping
- -Four (4) operable 3'x4' windows install in the 30'x 40' room on the left side
