Separate and sealed bids for the **Building Renovations at Ayrshire Electronics for Alcorn County, Mississippi**, will be received by the Alcorn County Board of Supervisors at the Alcorn County Board of Supervisors Building, 305 South Fulton Drive, Corinth, Mississippi, until 10:00 A.M., November 20, 2014, and then at said office publicly opened and read aloud.

Bid documents are being made available via original paper copy. The work consists of furnishing and installing HVAC appurtenances, water heaters, a gas space heater, an air compressor, new ceiling tiles, new stair treads, and dock door curtains. The work also consists of sealing and re-stripping a portion of the existing parking lot.

A conditional or qualified bid will not be accepted. Award will be made to the lowest responsible, responsive bidder.

Each bidder must deposit with this bid, security in the amount, form and subject to the conditions provided in the information for bidders. All bonds must be counter signed by a Mississippi Resident Agent.

No bidder may withdraw his bid within 90 days after the actual date of the opening thereof.
