Textile Programs

LIAT Furniture has partnered with C.F. Stinson and Mayer to provide graded in programs. Grades and availability of fabrics and textiles are subject to change without notice. These changes could include but are not limited to price increases, discontinued patterns, discontinued colors, etc.

COM

All COM yardage requirements are based upon 54" plain non-directional material. Additional yardage will be required for repeats of fabric less than 54" wide.

Patterned fabrics will be applied at our discretion unless special instructions are included with the order.


Lounge

Lounge

The lounge frames shall be constructed of 7/8" plytanium with locking dog bone joint construction that is then glued and stapled.

The seat is strapped with 3" Dymetrol Elastic Webbing and 3" thick cut soy-based foam with a 1/2" Dacron topper.

The backs are constructed with 2" Dymetrol Elastic Webbing and 2" thick cut soy-based foam.




Electrical / Power

The standard built-in power upgrade option shall be an all metal flush clamp mounted power and charging solution with 1 power and 2 USB 2.1A charging ports and a 108" cord length, constructed with 12A, 120 VAC spill resistant receptacles.

A 6 ft. electrical cord comes with the unit.

The unit shall be finished in a Metallic Silver powder coat.



Tablet Arms


Removable tablet arms are available in several styles. Tablet arms revolve 360 degrees. Tablets are available in either laminate or solid wood.

Canton tablet arms measure 13-1/2" W x 18" L and are located 8" from the top of the seat.

Laminate is the more durable of the two surfaces. If you select wood tablet arms keep in mind that the wood may show scratches or marking from objects used for various tasks.

Tablet arms are not designed for to be used for sitting, leaning, or supporting heavy objects, etc.

Good judgement of use and risk of breakage will be your sole responsibility.

Prices are those in effect at the time of order entry.

3. PAYMENT: Customer agrees to pay deposit or down payment as required by Company. Customer agrees to pay to Company the amount indicated on the Invoice, 1% 15 days, net 30 days from date of Invoice (U.S. Funds only), for Goods ordered. **INTEREST WILL BE CHARGED AFTER 30 DAYS FROM THE DATE OF INVOICE AT THE RATE OF ONE AND A HALF PERCENT (1.5%) PER MONTH.** International sales will require additional payment arrangements. No Goods shall be sold on consignment or conditional sales basis. Payment for the Goods delivered hereunder shall constitute acceptance thereof.
