# Specifications Guide

## General Construction

Everest shelving has a **modular island/starter/adder/end design**, which allows for easy re-configuration.

The standard species are Red Oak and Maple.

## Sizes

Selected sizes are nominal and actual dimensions vary depending on the selected unit type. Adder and End units have a width equal to the nominal width whereas Island and Starter units having a width that is **1"** larger than the nominal width, creating a run of shelving that is the selected nominal width on centers.

## Top Specifications

### Modular Top

The modular top shall be constructed of **1" thick** veneer core with grade "A" plain sliced veneer faces. The front edge shall receive a **3/4" thick x 1 3/4" high** valance. The cornice frame is grooved to accept the back panel. Back rail and end cleats are machined **1 3/4"** wide from solid wood. Tenon joints shall attach the end cleats to the fascia rail and back rail, then glued and pinned into a rigid structural frame and attached to the cornice panel with blind fasteners and glue. Holes are drilled in the end cleats for a bolt attachment to the end and intermediate panels. On shelving **72"** and above, the fascia is above the cornice to conceal the cleats from below and a **1/4"** panel is provided to conceal the cleats from above. On shelving less than **72"** high, the fascia is located below the cornice top.

Add **"-MT"** to the model number for this option.

### Continuous Tops

Continuous tops are available for all shelving units. The catalog numbers must be called out to indicate this selection. The HPL tops shall be 1-3/1" thick and come with a 3/4" eased internal edge band. If veneer tops shall come with a 3/4" external edge band.

*Veneer tops over 108" long will have seams.*

*HPL tops over 96" long will have seams.*

*Continuous tops are ordered separately from the shelving unit.*

Add **"-CT"** to the model number for this option.

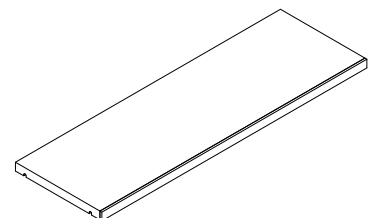
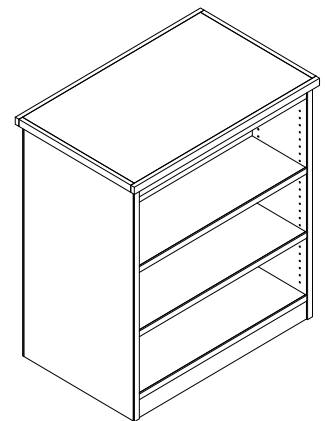
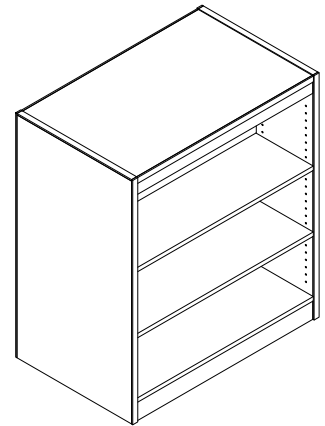
## Shelf Specifications

### Adjustable Shelf (Book Case)

The adjustable shelves shall be **1" thick** veneer core with grade "A" plain sliced veneer faces. Shelves shall have an eased external band on the front edge.

The underside of the shelf shall be routed to accept the shelf pins.

Add **"-BC"** to the model number for this option.

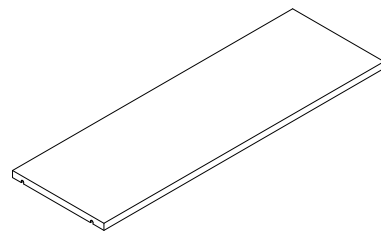


## Solid Shelf

The solid wood adjustable shelves shall be **3/4"** thick and constructed of glued-up continuous trips of solid Red Oak or Maple that are no less than **1"** and no more than **4"** in width. Wood species other than Red Oak or Maple shall not be acceptable.

*The underside of the shelf shall be routed to accept the shelf pins.*

Add **"-SS"** to the model number for this option.



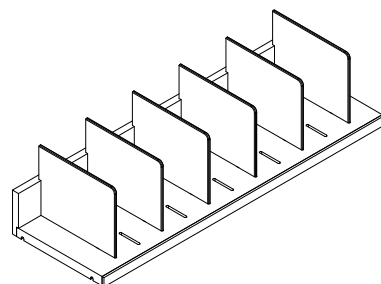
## Adjustable Divider Shelf

The adjustable shelves shall be **1"** thick veneer core with grade "A" plain sliced veneer faces. Shelves shall have an eased external band on the front edge.

*The underside of the shelf shall be routed to accept the shelf pins.*

There shall be a **3/4" thick x 4-3/4" high** veneer core ply back rail routed and glued to the shelf to accept **1/4" thick x 7-3/8" high** hardboard adjustable dividers.

Add **"-AD"** to the model number for this option.



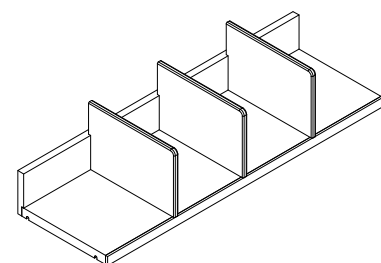
## Fixed Divider Shelf

The adjustable shelves shall be **1"** thick veneer core with grade "A" plain sliced veneer faces. Shelves shall have an eased external band on the front edge.

*The underside of the shelf shall be routed to accept the shelf pins.*

There shall be a **3/4" thick x 4-3/4" high** veneer core ply back rail routed and glued to the shelf. There shall be three **1/2" thick x 7-1/4" high** veneer core ply dividers glued to routes in the shelf and back rail.

Add **"-FD"** to the model number for this option.



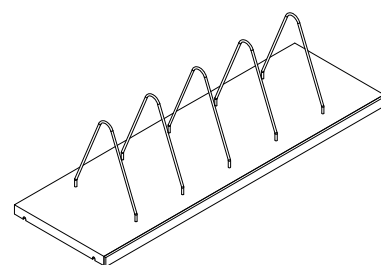
## Picture Book Shelf

The adjustable shelves shall be **1" thick** veneer core with grade "A" plain sliced veneer faces. Shelves shall have an eased external band on the front edge.

*The underside of the shelf shall be routed to accept the shelf pins.*

The top of the shelf shall receive **(5)** evenly spaced black wire dividers which shall be inserted into **3/16" diameter** holes.

Add **"-PB"** to the model number for this option.



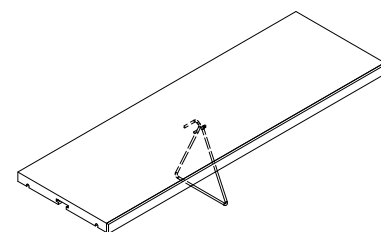
## Triangular Divider Shelf

The adjustable shelves shall be **1" thick** veneer core with grade "A" plain sliced veneer faces. Shelves shall have an eased external band on the front edge.

*The underside of the shelf shall be routed to accept the shelf pins.*

There shall be an additional route on the bottom of the shelf through the middle to accept a metal triangular divider.

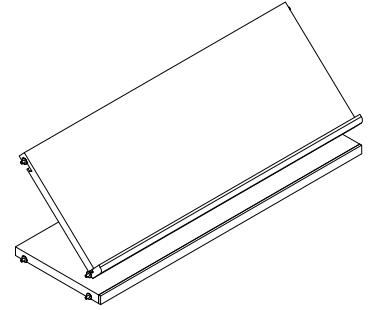
Add **"-TD"** to the model number for this option.



## Magazine Shelf

The magazine shelves shall be constructed of **1" thick** veneer core with grade "A" plain sliced veneer faces. The shelf shall have a solid hardwood retaining edge to hold the magazines in their inclined, displayed position. The shelf rests on four adjustable shelf pins pivoting upward on the rear pins to access the flat "adjustable" storage shelf beneath.

Add **"-MG"** to the model number for this option.

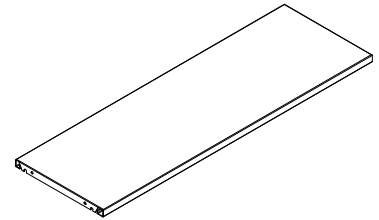


## Metal Shelf

The adjustable metal shelf shall be constructed of **20 gauge** steel. The shelf shall be **3/4" high** with the front and rear edges being square formed. The ends of the shelves shall be notched to accept the shelf pins.

*The shelves shall be powder coated.*

Add **"-MS"** to the model number for this option.



## Fixed Shelf

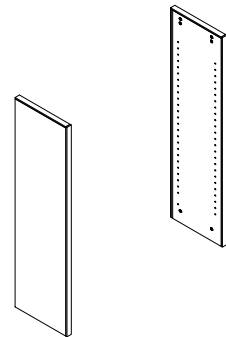
All units **60" and higher** shall require a shelf to be attached to the end and or intermediate panels by means of **(4)** L-shaped brackets and pan head wood screws that will align with the shelf pin holes on vertical panels.

## Panel Specifications

### End and Intermediate Panel

The end and intermediate panels shall be constructed **1" thick** veneer core with grade "A" plain sliced veneer faces. All double-faced end panels shall be banded on two vertical edges and the top edge, when required, with an eased **1/4"** solid hardwood external band. Single-faced panels are banded on the top, when required, and front edges with an eased **1/4"** solid hardwood external band. The inside faces of the panels shall have two rows of holes per face bored to accept shelf pins, spaced **32mm** apart on center.

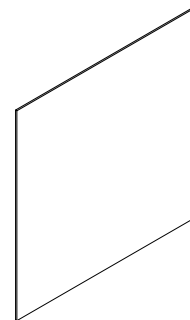
The panels shall be grooved to accept a **1/4" thick** back panel.



### Veneer Back Panel

The optional veneer back panel shall be **1/4" thick** plywood with select rotary cut face veneer on exposed face(s).

Add **"-VB"** to the model number for this option.

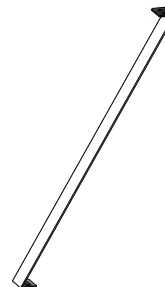


## Sway Straps

Sway straps are required when double faced units **60"** or higher are ordered with no back panels. Straps are made of **12 gauge** steel and bent at angles to attach to the end and intermediate panels on a diagonal. The end units of each run shall have a strap. On runs greater than four (**4**) units long, every other unit in a run shall have a strap. Each strap shall be finished with a black powder coat and attached with **#10 x 5/8"** pan head wood screws.

*Sway straps are only available for **36"** width units.*

*Sway straps must be ordered separately.*



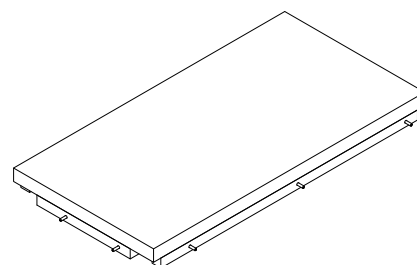
## Filler Specifications

### Corner Fillers

The corner fillers shall be constructed of **1"** thick plywood core with a Grade "A" veneer face. Solid hardwood cleats shall be provided for attachment to the shelving run and the wall.

*The depth and width is to be specified at time of purchase order.*

*For a proper fit, corner fillers may require trimming on installation.*

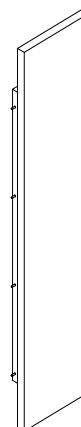


### Face Fillers

The face fillers shall be constructed of **1"** thick plywood core with a Grade "A" veneer face. Solid hardwood cleats shall be provided for attachment to the shelving run and the wall.

*The height and width is to be specified at time of purchase order.*

*For a proper fit, face fillers may require trimming on installation.*



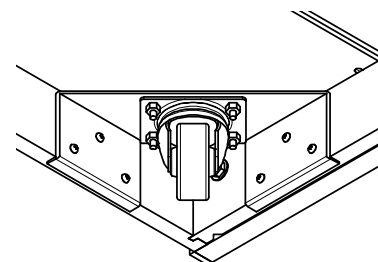
## Base Specifications

### Mobile Base

The mobile base upgrade is available on double face shelving units up to **60"** high. The swivel casters shall be bolted to the underside of the shelving unit by means of four metal corner brackets.

These brackets shall provide extra bracing by having four bends and attaching to the end panels and shelving base by means of wood screws.

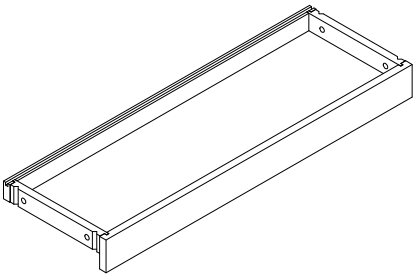
Add "**-CA**" to the model number for this option.



## Base Frames

The base frames are manufactured of solid kiln dried hardwood, the toe kick being of solid plain sawn Red Oak or Maple. The toe kick shall be full height at **3 1/4"**. The back rail and two end cleats shall be **1 3/4" high**. The end cleats are tenoned into the toe kick and back rail and glued and pinned into a rigid structural frame assembly. Holes are positioned into the end cleats for bolt attachment to the end and intermediate panels. A groove in the back rail shall house the back panels.

The end cleats on a double face shelving unit shall receive the groove to capture the back panel.



## Overall Size Specifications

### Height

See specific sections for available heights.

*Height selection may vary from the actual overall footprint height.*

### Depth

See specific sections for available depths.

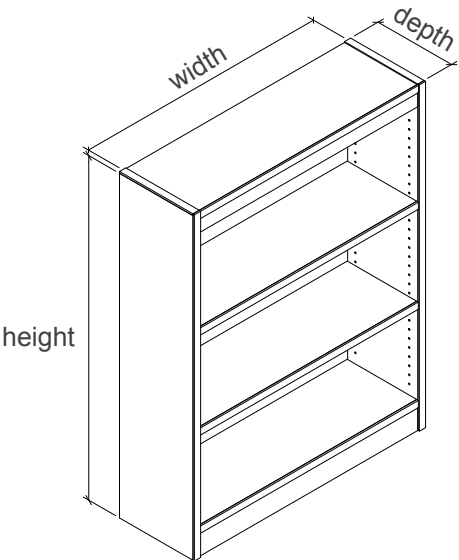
*Depth selection may vary from the actual overall footprint depth.*

### Width

See specific sections for available widths.

*Width selection may vary from the actual overall footprint width.*

*Each island and starter is 37" wide and each adder and end is 36" wide. This creates a run of shelving units that is 36" wide on centers.*



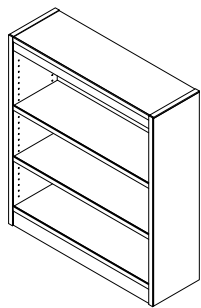

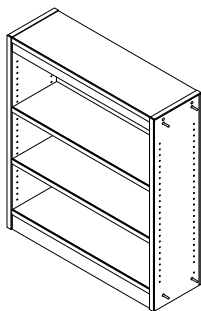

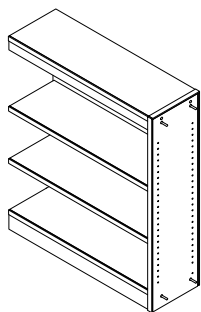
ISLAND

**Island** units are **stand-alone** or free-standing units.  
*Comes with 2 end panels*



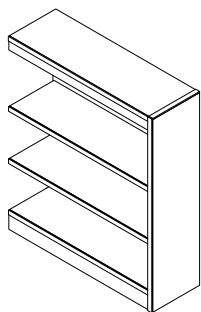
STARTER

**Starter** units act as a **starting point** for a run of shelving units.  
**All starters must be ordered with an end unit.**  
*Comes with 1 end panel and 1 intermediate panel*



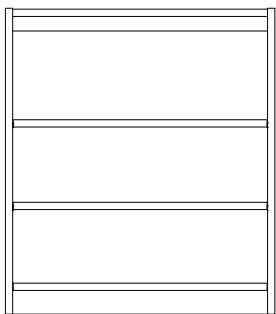
ADDER

**Adder** units act as an **extension** for a run of shelving units.  
**All adders must be ordered with both a starter and an end unit.**  
**There is no limit to the amount of adders allowed in a given run.**  
*Comes with 1 intermediate panel*

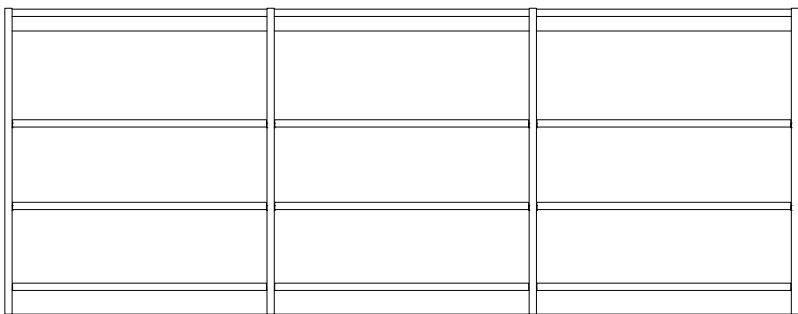


END

**End** units act as an **ending point** for a run of shelving units.  
**All ends must be ordered with a starter unit.**  
*Comes with 1 end panel*



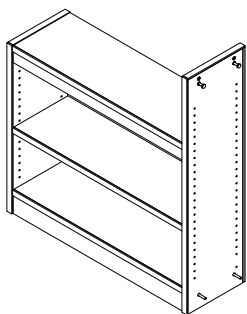

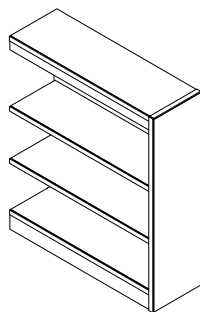

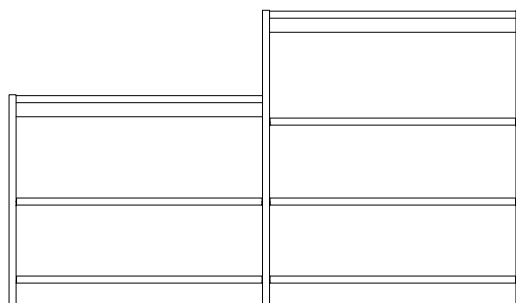
### EV-SH-3012-36BC-VB-S-MT-HA42

Since this starter has a height of **30"** we will need to designate an adapter. This unit comes with a built in **height adapter** designated by **-HA42**.



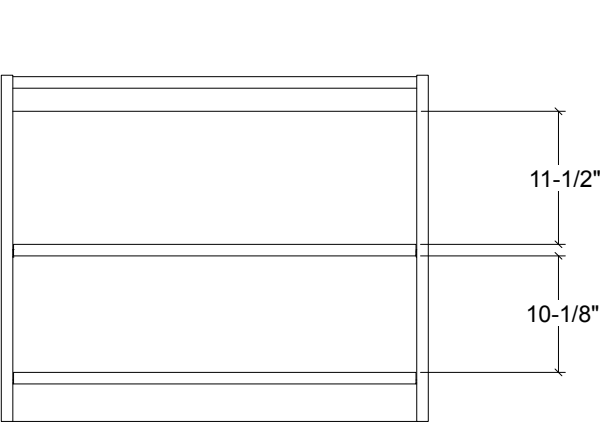

**Laminate Tops:** Laminates may be cleaned using a damp cloth and mild soap.

**Metal Finishes:** Mix a solution of liquid soap and warm water. Saturate a clean cloth with this mixture. Wipe down metal then dry completely.

Do **NOT** use any cleaner containing ammonia to clean your acrylic products. Do **NOT** use a dry cloth or your hand to clean the acrylic - this will rub the dirt and dust into the acrylic and can scratch the surface.

**Fabric Care:** The ability to be cleaned will vary based on the type of fabric. For best results, a professional service is recommended. Dirt and crumbs may be gently brushed or vacuumed off. Vinyl textiles can be cleaned with warm soapy water and then wiped down with a warm damp cloth.

Except for those obligations of the Company identified in these Terms and Conditions, all risks related to the quality and performance of the Goods and responsibility for repair or service costs rests solely on the Customer. Company reserves the right to limit the applicable warranty to the Goods depending upon the division or catalogue through which said Goods were sold. **12. REMEDIES:** The remedies herein reserved shall be cumulative, and additional to any other or further remedies provided in law or equity. No waiver of a breach of any provision of these Terms and Conditions shall constitute waiver of any other breach or of such provision.

**13. INSOLVENCY:** Company may forthwith cancel this order in the event of the happening of any of the following or any other comparable event: insolvency of the Customer, the filing of a voluntary petition in bankruptcy, the filing of any involuntary petition to have Customer declared bankrupt provided it is not vacated within thirty (30) days from the date of filing, the appointment of a receiver or trustee for Customer provided such appointment is not vacated within thirty (30) days from the date of such appointment, or the execution by Customer of an assignment for the benefit of creditors.

**14. LIMITATION OF LIABILITY:** The Company shall not under any circumstances be liable to the Customer, owner of the Goods or any third party for special, indirect, incidental, or consequential damages, including, without limitation, loss of profits or revenues, loss or damage to other property or equipment, cost of capital or of purchased or replacement goods, or expense, delay or inconvenience caused by or arising from the purchase, sale, use, repair or inability to use the Goods or by any performance or non-performance under, or breach of, these Terms and Conditions. The Company's sole liability for any defective Goods shall be its repair or its replacement pursuant to the Express Warranties set forth above, or if amended, as applicable at the time of manufacture or repair of the Goods.
