## **Promotion Process for the MS Highway Safety Patrol**

## Response to Questions on RFP #3120001242

1. Question: The RFP states that the Vendor shall "Develop, administer and score a Multiple Choice Examination for Master Sergeant ONLY. Candidates for Lieutenant or Captain shall be exempt from multiple choice exam". However, the Vendor shall also "Ensure that candidates for promotion to the ranks of Master Sergeant, Lieutenant, and Captain are evaluated based on three factors: (1) a Structured Examination including two components: the Written Exam and the Assessment Center; (2) an Administrative Interview; and (3) the Time and Education evaluation".

Will the candidates for Lieutenant and Captain be required to take a Multiple Choice Examination, based on the above three factors?

Answer: No, Candidates for Lieutenant and Captain DO NOT take the pre-entrance (Multiple Choice) exam. Master Sergeants have that extra step.

2. **Question:** Can you clarify Factor 1, Structured Examination including two components: the Written Exam and the Assessment Center?

**Answer:** There is to be a "Written" portion of the Structured Examination. Then the "Assessment" center will include the role plays, etc.

3. **Question:** If Master Sergeants ONLY take a Multiple Choice Examination will they also be required to complete another Written Examination per Factor 1? Additionally, are Master Sergeants required to complete Assessment Center?

**Answer:** Yes, Master Sergeants will take "written" portion of Structured Exam.

### Job Analysis:

4. Question: Does MDPS see the need for separate job analyses in each of the four respective

areas?

Answer: Each respective area will need a separate job analysis performed.

5. Question: Does MDPS want a complete job analysis or a review and revision of their

current job analysis?

Answer: MDPS is requiring a complete job analysis

6. Question: If a complete job analysis is required, will all incumbents in each rank be

required to complete the job analysis survey or only a sample of incumbents?

Answer: MDPS will not require all candidates to complete a job analysis survey.

Surveying a sample of incumbents will be sufficient.

7. Question: Do incumbents have unique email addresses and access to computers and internet

to complete an on-line job analysis survey?

Answer: Each incumbent has an email address.

### **Written Exam:**

8. Question: How many Master Sergeant candidates participated in the previous written

exams?

Answer: Approximately 300 total test were taken from Master Sergeant positions.

9. Question: Will multiple forms/versions of the written exam be necessary?

Answer: Yes

10. Question: How many questions are typically used on each written exam?

Answer: MDPS has never required a specific number of questions. However, MDPS

requires that multiple areas are covered so that skills and knowledge are revealed.

### **Assessment Center:**

11. Question: How many candidates participated in the previous assessment centers?

a. Master Sergeant candidates? Approximately 300

b. Lt candidates? Approximately 40c. Capt candidates? Approximately 70

12. Question: How many exercises were used in the previous assessment centers for each rank

and what were they?

**Answer:** The number of exercises in the previous assessment centers is unknown.

**Answer:** MDPS will be responsible for compensating assessors.

16. **Question:** Who will be responsible for reimbursing assessors for travel expenses?

**Answer:** MDPS will be responsible for reimbursing assessors for travel.

17. **Question:** Does MDPS prefer to audio/video recorded candidate performance of each assessment center exercise and then have the exercises scored later or would MDPS prefer to use live assessor panels scoring the candidates the day they complete their assessment center exercises?

**Answer:** MDPS prefers the use of live assessor panels for candidate scoring.

24. Question: Answer:	Is there a local small business goal associated with this RFP project?  No	
25. Question:	Approximately how many total candidates could participate in the promotional process for the three ranks of Master Sergeant, Lieutenant, and Captain? And, approximately how many of these will be in each division (Enforcement, Drivers' Services, MBI, and Motor Carrier) per rank?	
Answer:	Approximately 400 candidates could participate in the promotional process for the three ranks of Master Sergeant, Lieutenant and Captain. The largest number will come from the rank of Master Sergeant. If eligible, they would theoretically test in all four well. Captain would be the smallest of the three ranks. However, Captains could potentially test across the board.
