

NOTICE TO BIDDERS

Sealed proposals will be received by the Board of Supervisors of DeSoto County, Mississippi, until 10:00 a.m. on Friday, March 24, 2017, at the Office of Procurement, 365 Loshier Street, Suite 340, Hernando, Mississippi, for the county wide asphalt paving work for the Department of Road Management, DeSoto County, Mississippi, at which time they will be publicly opened and read aloud.

Work will be for a time period of 100 working days.

Specifications are on file in the Office of the County Engineer at 2373 Gwynn Road in Nesbit, Mississippi, and the Office of Procurement during normal business hours. All bids must comply with the specifications provided. The County reserves the right to amend the specifications upon reasonable notice to all that have examined and requested copies of those specifications.

Work will be let on a unit price basis.

The County reserves the right to reject any and all bids and to postpone for 45 days final decision and action on this bid.

Payment to be made within forty five (45) days of receipt of invoices submitted by the 15th of each month.

Each bidder shall comply with the laws of the State of Mississippi for bidding procedures and licensing requirements. All bids submitted in excess of \$50,000.00 by a prime contractor or subcontractor to do any building, construction, repair, maintenance or related work must comply with Section 31-3-21, Mississippi Code of 1972, by securing a Certificate of Responsibility from the State Board of Public Contractors or by showing a statement to the effect that the bid is less than \$50,000.00 and Certificate of Responsibility provision does not apply, on the outside of the envelope.

Certified Check or Bid Bond for five percent (5%) of total bid payable to DESOTO COUNTY must accompany each proposal.

Five Percent (5%) RETAINAGE will be held from each invoice and paid after the final acceptance of the project.

All bids submitted must be sealed, timely submitted, and clearly labeled on the outside of the bid envelopes as follows:
