Separate and sealed bids for the construction of ***STREET IMPROVEMENTS PRAIRIE COVE AND FROG MEADOW LANE, BID NO. 1483 PW*** will be received by the ***CITY OF TUPELO, CITY HALL, 71 EAST TROY STREET, SECOND FLOOR OF CITY HALL, FINANCE DEPARTMENT, ATTENTION: MISSY SHELTON, TUPELO, MS, 38804*** until ***10:00 A.M. FRIDAY, NOVEMBER THE 3RD, 2017*** and then at said office publicly opened and read aloud.

The Project consists of preparing the subgrade, installing a crushed limestone base, and applying hot mix asphalt pavement to Prairie Cove and Frog Meadow Lane in Tupelo, Mississippi. The subgrade preparation includes mixing and pulverizing the existing materials and grading and compacting this subgrade material. This work also includes other necessary items of work to complete this project. Prairie Cove is approximately 3300 feet in length and Frog Meadow is approximately 1350 feet in length.

Each bidder must deposit with this bid, security in the amount, form and subject to the conditions provided in the Information for Bidders.

No Bidder may withdraw his bid within 90 days after the actual date of the opening thereof.

Simultaneously with his delivery of the executed contract, the Contractor shall furnish surety bonds subject to the conditions provided in the Information for Bidders.

All applicable laws, ordinances and the rules and regulations of all authorities having jurisdiction over construction of the project shall apply to the contract throughout.
