The Board of Supervisors hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprise will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award.

PLANS AND SPECIFICATIONS are on file in the Desoto County Board of Supervisors Office, the County Engineer's office and the Office of the State Aid Engineer, 412 E. Woodrow Wilson Avenue, Jackson, Mississippi. Plans and proposals for this bid can also be found on the Procurement Page @desotocountys.gov at no cost or from Central Bidding at www.centralbidding.com for a fee. All bids must comply with the specifications provided. Desoto County reserves the right to amend the specifications, as necessary, and agrees to notify all having requested bid packets from the Desoto County office of Procurement. This project shall be constructed in accordance with the latest edition of the Mississippi Standard Specifications for State Aid Road and Bridge Construction.

PLANS AND PROPOSALS may be secured from Tracy M. Huffman, County Engineer for DeSoto County, Mississippi, 2475 Memphis Street, Hernando. The Cost is Seventy-Five Dollars and 00/10 (\$75.00) for plans and ten dollars (\$10.00) for the proposal, non-refundable.

Each bid shall be accompanied by a Cashier's Check, Certified Check on a solvent bank or a Bidder's Bond issued by a Surety Company licensed to operate in the State of Mississippi, in the amount of five percent (5%) of the total bid price, payable to the DeSoto County Board of Supervisors as bid security. Bidders shall also submit a current financial statement, if requested by the County. The successful bidder will be required to furnish a Performance Bond and a Payment bond each in the amount of one hundred percent (100%) of the contract amount.

Bidders are hereby notified that any proposal accompanied by letters qualifying in any manner the condition under which the proposal is tendered will be considered an irregular bid and such proposal will not be considered in making the award.

The Proposal and contract documents in its entirety shall be submitted in a sealed envelope and deposited with the DeSoto County Office of Procurement, 365 Loshier Street, Suite 340, Hernando, MS 38632 prior to the hour and date

above designated. NO stripped bids will be accepted.
