

The Town of Kilmichael is soliciting bids for three (3) homeowner housing units that will be demolished and rebuilt under the town's HOME rehab grant program. Sealed, written bids will be received at the Town of Kilmichael's Town Hall, 114 North Depot, Kilmichael, MS 38747 until 4:30 p.m., on Friday, December 18, 2015. They will be publicly opened and read aloud at the Mayor and Board of Aldermen's Meeting at 7:00 P.M at the Town of Kilmichael's Town Hall on Tuesday, January 5, 2016.
