ADVERTISEMENT FOR BIDS FOR ASPHALT

Notice is hereby given that the Mayor and Board of Aldermen of the City of Batesville, Panola County, Mississippi, will receive written, sealed bids at its office at the Batesville City Hall at 103 College Street in Batesville, Mississippi, until 2:00 p.m. C.S.T. on Tuesday, December 1, 2015, for the following. Each bid should be plainly marked with “**Bid**” and “**Item Number**” and placed in an envelope before delivered to City Hall.

1. Hot bituminous asphalt mix SC-1, Type 8 or other approved Mississippi Department of Transportation (MDOT) hot bituminous asphalt surface course; to be purchased, delivered, and applied to City streets.
 - Streets range from approximately eighteen (18) feet to thirty (30) feet in width. Minimum asphalt overlay will be in one and a half (1.5) inch lifts.
 - This is a term bid contract in which the price shall include full compensation for material, equipment, labor, transportation, cleaning, traffic control, and maintenance of traffic as required to complete construction operations.
 - The minimum tonnage will be five-hundred (500) tons and the minimum applied at any one time shall be one-hundred (100) tons.
 - A list of the estimated streets to receive this work and the estimated tonnages can be obtained from the City of Batesville upon request.

2. Cold milling of bituminous pavement; to be removed and disposed of.
 - Streets range from approximately eighteen (18) feet to thirty (30) feet in width. Minimum cold milling of bituminous pavement will be one (1) inch depth.
 - This is a term bid contract in which the price shall include full compensation for material, equipment, labor, transportation, cleaning, traffic control, and maintenance of traffic as required to complete construction operations.
 - The minimum tonnage removed will be one-hundred (100) tons and the minimum removed at any one time shall be fifty (50) tons.
