Interested parties may contact the Sunflower County Administrator at 662-887-4703 to arrange an appointment for inspection of such property. Said property will be sold without warranty or guarantee by Sunflower County of any nature whatever, either express or implied, and Sunflower County makes no warranty as to the fitness of such property for any particular purpose. Said property will be sold on an "as is - where is" basis, except that any specialized lighting, law enforcement or emergency management equipment and radios will be removed before delivery, and delivery will not be made until new replacement vehicles have been purchased by and delivered to Sunflower County, MS. Immediately following the opening of sealed bids, any person who submitted a written sealed bid on a particular vehicle shall be entitled to increase same, with the final high bid for such vehicle to be then considered and accepted by the Board of Supervisors. Any company or individual desiring to purchase such property must tender cash or a cashier's check for the full purchase price thereof by 5:00 o'clock, p.m. on Friday, January 22, 2016. If the successful bidder for such property has not paid for the same by either tendering a cashier's check or cash as set forth above by said date and time, then the County Board of Supervisors shall be entitled to reject such bid and to thereafter accept the next highest bid as the successful bidder for such property. The Board of Supervisors reserves the right to reject any bid and to waive any informalities in any bid, and to make allowances in time for payment, as may appear to be in its best interests.
