

NOTICE TO BIDDERS

The Board of Supervisors of Stone County, Mississippi, will receive sealed bids until 10:00 a.m. CST on the 7th day of March, 2016, at the Chancery Clerk's office in the Stone County Courthouse, Wiggins, Mississippi, for the privilege of furnishing to Stone County the following supplies, personal property and/or services, to-wit:

ITEM #01 – LIMESTONE: Chip Seal - in place #7 rock.

ITEM #02 – LIMESTONE: Matt and Seal – in place, #5 matt rock, #7 seal rock.

NOTE: THE TERM OF SUCH BID SHALL BE FROM ACCEPTANCE OF THE BID BY THE STONE COUNTY BOARD OF SUPERVISORS DOWN TO AND INCLUDING DECEMBER 31, 2016, AND CONTINUING THEREAFTER UNTIL ANOTHER SUPPLIER OF SUCH ITEMS IS SECURED.

NOTE: ALL BIDDERS SHALL STATE THE LOCATION OF THE BIDDER'S PLANT FOR WHICH THE BID IS SUBMITTED, AND THE NUMBER OF HIGHWAY MILES SUCH PLANT IS LOCATED OR POINT OF SUPPLY FROM THE STONE COUNTY COURTHOUSE, WIGGINS, MISSISSIPPI, FOR ALL BID ITEMS WHICH ARE NOT BID DELIVERED F.O.B. TO STONE COUNTY JOBSITE.

NOTE: NON-RESIDENT BIDDERS ON COUNTY CONTRACTS MUST SUBMIT WITH THEIR BID A COPY OF THE STATE LAW OF THE DOMICILE OF THE BIDDER PERTAINING TO ITS TREATMENT OF NON-RESIDENT CONTRACTORS.

Specifications thereof and required bid forms are now on file with the Clerk of said Board and subject to public inspection and copying from 8:00 a.m. until 5:00 p.m., Monday through Friday, at the office of said Clerk in the Stone County Courthouse, Wiggins, Mississippi. In all applicable classes and groups, the materials and supplies shall meet the State of Mississippi highway or other applicable standards and specifications unless otherwise stated in the proposal and accepted by the county.

All such bids shall include a statement that the amount bid does not exceed the price permitted by law.
