ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the Pascagoula Beachfront Promenade will be received by the City Clerk of the City of Pascagoula, 603 Watts Avenue, Pascagoula, MS 39567-4220 until 2:00 P.M., local time on April 5, 2016, at which time the Bids received will be publicly opened and read. The project consists of constructing approximately 8,200 linear feet of concrete pedestrian pathway and plaza areas. The project will also include a roadway lighting system, shade structures, landscaping and other related work.

All bids shall be submitted in a sealed envelope addressed to the City Clerk of the City of Pascagoula, Mississippi. If a bid is submitted by mail, the post office address of the City Clerk is P.O. Drawer 908, Pascagoula, Mississippi 39568-0908.

All bids should contain the bidder's name and mailing address on the face of the envelope and should specify the name of the bid package.

Bids will be received from a single prime Contractor. Bids shall be on a unit price basis, with additive alternate bid items as indicated in the Bid Form.

This Issuing Office for the Bidding Documents is Brown, Mitchell & Alexander, Inc., 796 Vieux Marche, 2nd Floor, Biloxi, MS 39530, (228) 436-7612. Prospective Bidders may examine the Bidding Documents at the Issuing Office on Monday through Friday between the hours of 8:00 A.M. and 5:00 P.M., and may obtain copies of the Bidding Documents from the Issuing Office as described below.

Bidding Documents may be obtained from the Issuing Office during the hours indicated above.

Bidding documents are available on compact disc (as pdf files) for a non-refundable charge of \$75.00.

The date that the Bidding Documents are transmitted by the Issuing Office will be considered the prospective Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda, if any, obtained from sources other than the Issuing Office.

A pre-bid conference will be held at 10:00 A.M., local time on March 18, 2016 at the City of Pascagoula City Hall, 603 Watts Avenue, Pascagoula, MS. Attendance at the pre-bid conference is highly encouraged but is not mandatory.

Bid security shall be furnished in accordance with the Instruction to Bidders.

For bids exceeding \$50,000.00, Bidder must indicate his Certificate of Responsibility Number on the outside of sealed proposal as required by Mississippi Law. Effective July 1, 2010; Per MS Code 31-3-21(3); any bid submitted by a non-resident contractor which does not include the non-resident contractor's current state law pertaining to such state's treatment of non-resident

contractors, shall be rejected and not considered for award. If no such law exists in the non-resident contractor's state, then the non-resident contractor may provide a statement to that effect.

No bidder may withdraw his bid within sixty (60) days after the actual date of the opening thereof.

The City reserves the right to reject any or all bids not conforming to the intent and purpose of the specifications and to postpone the award of the Contract for a period of time which shall not extend beyond sixty (60) days from the bid opening date.
