A pre-bid conference for this project will be held at Paul Pittman Memorial Airport on Tuesday, July 7, 2015 at 1:00 PM.

Each proposal must be accompanied by a bid guaranty in the amount of five (5) percent of the total amount of the bid. The bid guaranty may be by certified check or bid bond made payable to **Walthall County Board of Supervisors.**

Bids may be held by the **Walthall County Board of Supervisors** for a period not to exceed 60 days from the date of the bid opening for the purpose of evaluating bids prior to award of contract. The award of the contract is dependent on the final approval of federal funds. The right is reserved, as the Walthall County Board of Supervisors may require, to reject any and all bids and to waive any informality in the bids received.

This project is subject to the requirements of the Davis-Bacon Act, as amended. The Contractor is required to comply with wage and labor provisions and to pay minimum wages in accordance with the schedule of wage rates established by the United States Department of Labor.
