

NOTICE TO CONTRACTORS

Separate sealed bids for construction of **ASPHALT REJUVENATION & STRIPING** for the **MONROE COUNTY AIRPORT (AIP PROJECT NO. 3-28-0001-015-2016)**, will be received by the **MONROE COUNTY BOARD OF SUPERVISORS** located, at **201 W. Bids will be accepted only under the name of the Bidder to whom contract documents have been issued by the Engineer.

Bids must be submitted on the standard form of bid proposal, and the successful bidder will be required to execute the standard form of Contract Agreement, together with a 100% Performance Bond and Payment Bond, within ten (10) days after formal award of the contract.

Bids may be held by the County for a period not to exceed 60 days from the date of the opening of Bids for the purpose of reviewing the bid and investigating the qualifications of Bidders, prior to awarding of the Contract.

The **MONROE COUNTY BOARD OF SUPERVISORS** reserves the right to reject any and all bids and to waive any and all information in the best interest of the Owner.
