To be eligible, the applicant must be registered with IATAN, working a minimum of 20 hours per week and earning the minimum of \$5,000 per annum in salary and/or commissions. Please note owners of record with a 20% interest or more in the business are exempt from the earnings requirements.

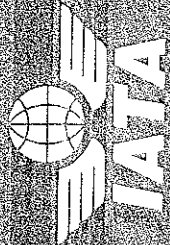
