


Request for Bids

Notice is hereby given that the Executive Director of the Harrison County Utility Authority will receive sealed bids until 10:00 A.M., Friday September 11, 2015 at the Utility Authority Office, located 10271 Express Drive, Gulfport, MS 39503 for the furnishing of chlorine and sulfur dioxide, for use at the Utility Authority Facilities. Bids delivered after the designated time will be returned unopened. The bid prices will be good for (2) two years and the Authority will have the option to extend the price for an additional year, at their sole discretion. Bids shall be submitted in a sealed envelope marked on the outside as follows: "Harrison County Utility Authority CL2 & SO2 Purchase"

Bidders will submit their bids on the form provided in the bid specifications package, provided by the Utility Authority. Failure to do so will disqualify the bidder. Bid forms, including specifications and other details, may be obtained from the Utility Authority office, between the hours of 8:00 A.M. and 5:00 P.M., Monday through Friday, or by calling the Harrison County Utility Authority (228) 868-8752.

Bids must be submitted as stated on this request. Failure to do so will disqualify your bid.

The Harrison County Utility Authority reserves the right to accept or reject any and all bids and to waive technicalities, if deemed in the best interest of the Utility Authority.

QUANTITY OF MATERIALS

The Contractor shall be prepared, to furnish and deliver, on an as needed basis, the following amounts, in specified cylinder sizes as follows: * **See Attached Sheet**

The amounts listed are estimates based on historical data. There is no guarantee that the Authority will purchase or use these amounts.

APPLICABLE LICENSES, LAWS, AND REQUIREMENTS

The Contractor shall be responsible for obtaining all applicable business licenses, hauling permits, and meet all EPA or state requirements required to fulfill this contract and shall comply with the laws, ordinances, rules, and regulations of the jurisdiction in which the work may be performed.

DELIVERY REQUEST

The Chlorine and Sulfur dioxide shall be delivered on an as needed / will call basis. Upon receiving an authorized telephone / faxed request, the Contractor shall complete delivery within 72 hours. In the event that a partial delivery is necessary the remaining items to make the order complete, must be delivered within 72 hours after the first delivery. The Authority reserves the right to reject any material ordered from the Contractor if delivered subsequent to the terms hereto necessitating the placing of such orders elsewhere, or if signs of chemical leak is evident.

DELIVERY REQUIREMENTS/LOCATIONS/TIME OF DELIVERY

The Contractor shall deliver the Chlorine and/or Sulfur Dioxide to the Authority Wastewater and Water Facilities.

All drivers must be trained in safe handling and delivery of Chlorine and/or Sulfur Dioxide. All drivers must have a current Commercial Driver's License (CDL) and must be able to produce such on demand. All drivers must have completed a course in hazardous material handling.

The Contractor is responsible for any leak, spill, or property damage that may occur while delivering or unloading the Chlorine and/or Sulfur Dioxide.

Time of Delivery: Between 8:00 am. — 3:00 p.m., Monday through Friday except for the Authority observed holidays.

The Authority reserves the right to procure Chlorine and/or Sulfur Dioxide for emergency purposes from any party who can provide more prompt service without waiving or voiding any of the terms or conditions of this contract.

BID SPECIFICATIONS

CHLORINE AND SULFUR DIOXIDE FOR WASTEWATER AND WATER FACILITIES

It is the intent of the Harrison County Utility Authority (Authority) to establish a contract for furnishing and delivering chlorine and sulfur dioxide in liquid form on an as-needed / will call basis for the term and quantities described herein to the Authority Wastewater and Water Facilities in accordance with the attached specifications. Quantities are estimated and do not imply or represent a commitment to purchase these quantities. Authority usage will be based on the specific needs of our facilities.

Contractor shall furnish all management, labor, components, materials, transportation, tools, and appurtenances necessary for the performance and completion of this contract in the manner called for by the terms and conditions herein and to the satisfaction of the Harrison County Utility Authority.

CONTRACT ADMINISTRATOR

QUALITY OF MATERIAL

Chlorine must conform to AWWA standard B301-4. It must also meet the following standards:

The contractor shall submit an affidavit attesting that the liquid chlorine furnished under this contract shall meet the purity requirements.

Sulfur Dioxide must conform to AWWA standard B512-02

FAILURE TO MAKE DELIVERIES

In the event the Contractor fails to make delivery when ordered, in accordance with the terms specified herein, the Authority shall then have the right to procure Chlorine and/or Sulfur Dioxide on the open market or by contract, in which event, the extra cost of such material, above the contracted price, shall be charged against the Contractor and be deducted from any monies due or which may become due, to the Contractor.

ADDITIONAL BID REQUIREMENTS

The Contractor shall indemnify, protect, and save the Authority harmless from all losses, liens, suits, judgments, proceedings, including attorney's fees, of whatever nature arising out of the conduct and work or the failure of the Contractor to furnish materials and labor for the violation of any regulation, rule ordinance, statute, or law, and any failure to complete the execution of the work as herein specified and agreed.

The Contractor shall carry the necessary insurance as may be required by the Authority. Minimum insurance coverage shall be:

Failure to comply with any requirement shall be grounds for termination.

Bidder shall provide information on its safety record for the past two (2) years, including information on spills, releases, injuries, and OSHA / Environmental violations / non-compliances. Historical environmental and safety performance will be considered in the evaluation of bids.
