The work shall consist essentially of the following items:

- 1) Items of work shall include erosion control, earthwork, and concrete sidewalk.

A Pre-Bid Conference will be held on Thursday, August 13, 2015 at 10:00 a.m. local time at the office of Dungan Engineering, P.A., 925 Goodyear Blvd., Picayune, Mississippi, 39466. All interested parties are urged to attend this conference.

The above general outline of features of the work does not in any way limit the responsibility of the Contractor to perform all work and furnish all plant, labor, equipment and materials required by the specifications and the drawings referred to therein.

The attention of bidders is directed to the Contract Provisions governing selection and employment of labor. Minimum wage rates for Federal-Aid projects have been predetermined by the secretary of Labor and are subject to Public Law 87-581 Work Hours Act of 1962, as set forth in the Contract Provisions.

The City of Picayune of Pearl River County hereby notifies all Bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, disadvantage and women's business enterprises will be afforded the full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration of an award.

**The award of this contract will be contingent upon the Contractor satisfying the DBE/WBE requirements.**

Each bid shall be accompanied by a Certified Check on a solvent bank or a Bidder's Bond issued by a Surety Company, licensed to operate in the State of Mississippi, in the amount of five percent (5%) of the total bid price, payable to the City of Picayune as bid security. Bidders shall also submit a current financial statement, if requested by the City of Picayune. The successful bidder will be required to furnish a Contract Bond in the amount of one hundred percent (100%) of the contract amount.

The proposal and contract documents in its entirety shall be submitted in a sealed envelope and deposited with the City Clerk, 203 Goodyear Boulevard, Picayune, Mississippi prior to the hour and date above designated. No bidder may withdraw his bid within sixty (60) days after the date of actual bid opening, without Owner's consent.

Work to be performed shall be in accordance with the "Mississippi Standard Specifications for Road and Bridge Construction, 2004", together with all amendments and/or special provisions and /or addenda to the standards duly approved and adopted, unless otherwise noted in these specifications.
