





The Board of Supervisors of Claiborne County hereby notifies all Bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, disadvantaged and women's business enterprises will be afforded the full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award.

The award of this contract will be contingent upon the Contractor satisfying the DBE/WBE requirements.

PLANS AND SPECIFICATIONS are on file in the Office of the Claiborne County Board of Supervisors, 510 Market St., Port Gibson, MS 39150 (601) 437-4992 and the Engineer's office, IMS, 126 East Amite Street, Jackson, Mississippi 39201. This project shall be constructed in accordance with the latest edition of the Mississippi Standard Specifications for State Aid Road and Bridge Construction.

PLANS AND PROPOSALS may be secured from IMS Engineers at 126 East Amite Street, Jackson, Mississippi 39201. The cost is two hundred dollars (\$200.00) for plans and fifty dollars (\$50.00) for the proposal, non-refundable.
