

INSTRUCTION TO BIDDERS AND CONTRACT DOCUMENTS

INVITATION TO BID

Sealed bids will be received by the Gulfport-Biloxi Regional Airport Authority (herein called "GBRAA" or the "Owner") in the Office of Executive Director, 3rd floor, Passenger Terminal Bldg., Gulfport-Biloxi International Airport, 14035-L Airport Road, Gulfport, MS 39503, until **2:00 o'clock PM local time, Tuesday, March 10, 2015** and then in the GBRAA conference room on the 3rd floor, Passenger Terminal Bldg., Gulfport, MS shortly thereafter publicly opened for:

Construction consisting of furnishing, installing and otherwise completing the Gulfport-Biloxi Regional Airport Authority Residential Sound Insulation Program Phase 7D known as Federal Airport Improvement Program Project No. 3-28-0030-077-2011 in Harrison County.

The attention of bidders is directed to the Contract Provisions governing selection and employment of labor. Minimum wage rates have been predetermined by the Secretary of Labor and are subject to Public Law 87-58-1, Work Hours Act of 1962, as set forth in the Contract Provisions.

The Owner hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, disadvantaged business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, sex, religion or national origin in consideration for an award.

The award of this contract will be contingent upon the Contractor satisfying the DBE requirements. The DBE participation goal for this contract is 11.96%. The bidder (proposer) will be required to submit information concerning the DBE's that will participate in this contract (subcontract). The information will include the name and address of each DBE, a description of the work to be performed by each named firm, and the dollar value of the contract (subcontract). If the bidder fails to achieve the contract goal as stated herein, the bidder must include documentation demonstrating that it made good faith efforts in attempting to do so. A bid that fails to meet these requirements will be considered non-responsive.

In order to be considered, a bid for Phase 7D must be sealed, and have clearly written on the face of the envelope the following: **“Sealed bid enclosed for Gulfport-Biloxi Regional Airport Authority Residential Sound Insulation Program Phase 7D to be opened 2:00 PM, March 10, 2015”**

Bid bond, signed or countersigned by a Mississippi Resident Agent, with Power of Attorney attached, a Cashier's check or certified check for five (5%) percent of bid, payable to the Owner, must accompany each proposal.
