Two (2) – Four (4) Wheel Drive New Holland Cab Tractors with Rear Cradle Boom Mowers

BACKGROUND

Neshoba County, through State Contract Procurement means, will be purchasing two (2) four (4) wheel drive New Holland Cab Tractors with Rear Cradle Boom Mowers through two separate vendors – one providing the tractors and one providing the boom mower attachments to make a complete assembly.

SOLICITATION

Through this single solicitation, Neshoba County wishes to secure lease purchase financing for the purchases of said equipment.

In response to this solicitation please provide a detailed proposal including an amortization schedule for said lease-purchase, with a 60 month term (60 monthly payments) and the Interest Rate provided. Please provide a complete proposal indicating any additional information and/or requirements necessary in response to this solicitation.

So that the lowest and best lease-purchasing financing proposal can be accepted soon after the bid opening, please provide the necessary authorizing resolution and all closing documents which can be executed after acceptance of the bid.
