Roadways of Reunion Parkway and Highland Colony Parkway

The Madison County Board of Supervisors will receive sealed bids for the construction of Reunion Parkway and Highland Colony Parkway for a total project length of 4.22 miles, Federal Aid Project No. STP-0045-00(024)LPA/106482-701000, no later than 10 A.M. Local Time on July 27, 2016, at the Madison County Courthouse Chancery Clerk's Office, located at 125 West North Street, Canton, Mississippi 39046. All bids so received will be publicly opened and read aloud. The work shall consist essentially of the following items:

Repair and overlay of Reunion Parkway, and Highland Colony Parkway and all other related items of work required to complete the project as shown and specified in the Contract Documents.

The above general outline of features of the work does not in any way limit the responsibility of the Contractor to perform all work and furnish all parts, labor, equipment, and materials required by the specifications and the drawings referred to therein.

A Pre-Bid Conference will be held at 10 A.M. July 19, 2016, in the Madison County Courthouse, Chancery Clerk's Office in Canton, Mississippi.

The attention of bidders is directed to the Contract Provisions governing selection and employment of labor. Minimum wage rates for Federal-Aid projects have been predetermined by the Secretary of Labor and are subject to Public Law 87-581 Work Hours Act of 1962, as set forth in the Contract Provisions.

The Madison County Board of Supervisors hereby notifies all Bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, disadvantaged and women's business enterprises will be afforded the full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award.

The award of this contract will be contingent upon the Contractor satisfying the DBE/WBE requirements.

The Contract Documents are on file and may be examined at the following locations:

1. At the Madison County Courthouse, Chancery Clerk's Office in Canton, Mississippi 39046.
2. Waggoner Engineering Inc. located at 143-A LeFleurs Square, Jackson, Mississippi, 39211. All documents required for bidding purposes may be obtained from Waggoner Engineering, Inc. upon payment of \$150.00 for each set, which will not be refunded.

Each bid shall be accompanied by a Certified Check on a solvent bank or a Bidder's Bond issued by a Surety Company licensed to operate in the State of Mississippi, in the amount of five percent (5%) of the total bid price, payable to the Madison County Board of Supervisors as bid security. Bidders shall also submit a current financial statement, if requested by the Board. The successful bidder will be required to furnish a Performance Bond and a Payment Bond, each in the amount of one hundred percent (100%) of the contract amount.

3. The proposal and contract documents in its entirety shall be submitted in a sealed envelope and deposited with the Madison County Chancery Clerk's Office in Canton, Mississippi, prior to the hour and date above designated. No bidder may withdraw his bid within sixty (60) days after the date

of actual bid opening without Owner's consent.

Work to be performed shall be in accordance with the "Mississippi State Highway Standard Specifications for Road and Bridge Construction, 2004", together with all amendments and/or special provisions and/or addenda to the standards duly approved and adopted, unless otherwise noted in these specifications.

The attention of Bidders is directed to the provisions of Subsection 102.07 pertaining to irregular proposals and rejection of bids.
