AMENDATORY RIDER #1

PERSONAL SERVICE CONTRACT

WHEREAS, the Office of the Attorney General, a state agency, (the "OAG") whose address is 550 High Street, Sillers Building, 12th Floor, Jackson, Mississippi 39201 and YMCA of Metropolitan Jackson, (the "CONTRACTOR") whose address is 800 East River Place, Jackson, Mississippi 39202, entered into a Personal Service Contract (the "Contract") effective July 1, 2014, under which the CONTRACTOR agreed to provide services as specified under the terms of the Contract at Section 1. WHEREAS, the OAG and the CONTRACTOR desire to amend Section 3. of the Contract, to reflect the not to exceed amount of Twenty-five Thousand Nine Hundred Twenty Dollars (\$25,920.00) with a maximum of Twelve Thousand Nine Hundred Sixty Dollars (\$12,960.00) expended per fiscal year.

NOW THEREFORE, the OAG and the CONTRACTOR covenant and agree, each to the other, that Section 2. of the Contract shall be and hereby is amended to reflect an end date of June 30, 2016, effective June 29, 2015, as stated herein above and that Section 3. of the Contract shall be and hereby is amended to reflect a not to exceed amount of Twenty-five Thousand Nine Hundred Twenty Dollars (\$25,920.00) with a maximum of Twelve Thousand Nine Hundred Sixty Dollars (\$12,960.00) expended per fiscal year.

FURTHER, the Contract now consists of this Amendatory Rider #1 and the Contract as referenced above. Any ambiguities, conflicts or questions of the interpretation of this Contract shall be resolved by first reference to this Amendatory Rider #1, and, if still unresolved, by reference to the Contract:

Except as specifically stated herein, all other terms and conditions of the Contract shall remain in full force and effect as originally stated.
