ORDER ENTRY

All orders are subject to final acceptance by Fairfield Chair Company in Lenoir, NC. No order will be entered for production or acknowledged until ALL specification information is complete (see above).

Fairfield Chair Company attempts to clarify all purchase orders. **However, in the event the model number and description on the purchase order differ, the model number will prevail.**

Acknowledgments will be made for each accepted order and contain the final order specifications on it. The buyer is responsible for checking the acknowledgment to make sure that every detail is correct. If any errors are found, it is the buyer's responsibility to contact our Order Entry Department immediately.

Receipt of our acknowledgment indicates acceptance of your order subject to the terms set forth on the acknowledgment.

Fairfield Chair Company cannot be responsible for errors made on any orders taken over the phone if written confirmation from the buyer has not been received.

Any duplicate orders not clearly marked "Confirmation" are the responsibility of the buyer.

CANCELLATIONS & CHANGES

Because all upholstery items are manufactured to the buyer's specifications, acknowledged orders cannot be canceled for any reason without the written authorization of Fairfield Chair Company. No verbal cancellations will be accepted, either from reps or customers. ALL CANCELLATIONS MUST BE WRITTEN (either faxed, mailed or e-mailed). If a cancellation is approved, it will be subject to a charge of up to 50% of the net price. Orders for custom merchandise cannot be canceled for any reason (any modification to items included in this price list is considered custom).

Fairfield Chair Company is not required to accept any changes to orders. For any accepted and authorized changes, Fairfield Chair Company reserves the right to charge for any expenses incurred due to the change. This includes fabric and other materials, labor, and any other costs, plus up to 25% of the net price. Order changes may also change production and ship date of your order.

SHIPPING & STORAGE

Fairfield Chair Company will ship in accordance with customer instructions whenever possible. Orders in production will be shipped as scheduled and cannot be held. If a customer is unable to accept an order when it is ready for shipment, storage may be requested. Acceptance of a storage request will be at the discretion of Fairfield Chair Company. All costs including transportation will be at customer's expense. A storage charge of 1.5% of the invoice will be assessed for every 30 days, or any part thereof, that merchandise remains in storage. Fairfield Chair Company considers transfer to storage the equivalent of delivery. This includes invoicing and payment. Customers will bear all risk of damage or loss during storage.

RETURNS

Fairfield Chair Company will not accept returned merchandise without a signed Return Authorization issued by our Customer Service Department. If a return is authorized, it is the sole responsibility of the buyer to make sure that the product is cartoned to prevent any further damage. The only reasons we would consider a return are for a manufacturing defect or an error in our order processing. Defective items must be inspected and confirmed by a Fairfield Chair Company representative. Proper documentation, including digital photos of the defect must accompany the request.

If a return is authorized, the item must be received at Fairfield Chair Company within thirty (30) days of the date of the RA. Any freight damage, signs of use, missing parts, etc. will affect the amount of the credit issued to the buyer. Unauthorized returns will be automatically refused at our dock, and Fairfield Chair Company will not be liable for any damages or losses.

Liability for defective merchandise shall be limited to the replacement or repair of that merchandise, and Fairfield Chair Company shall not be liable for other damages or losses.

FREIGHT DAMAGE & CLAIMS

Fairfield Chair Company is not liable for any damages to products that occur during Transit or storage. The carrier assumes all responsibility upon acceptance of product. It is the buyer's responsibility to inspect products upon receipt and file any claims with the carrier. If products are received damaged, a written exception should be made on the bill of lading and an immediate inspection be requested of the carrier. Concealed damage must be reported to the carrier within 15 days of receipt. Failure to make claims shall constitute acceptance of the products and waiver any claims of defects, errors or shortages.

"THIRD PARTY", "NOTIFY" AND "WILL ADVISE" ROUTINGS

Orders requesting special routing instructions such as "Third Party", "Notify" or "Will Advise", please note the following information:

Important Shipping Information: Carrier must call (828) 610-2587 or fax (828) 726-8770 at least 24 hours in advance of pickup <u>with Acknowledgment number(s) to insure orders are ready</u>. Shipping hours are: 7 AM - 2 PM, Monday - Friday. Upon pickup, carrier must furnish Acknowledgment number(s) to insure correct orders are released.

Arm Covers

Arm covers are optional for an additional charge of \$92 per set in fabric and \$122 per set in leather. The price of arm covers will be added to the acknowledged unit price of the merchandise. Exact shade match of fabrics cannot be guaranteed due to variations of dye lots.

CARB Compliance

The California Air Resources Board (CARB) is a department of the California Environmental Protection Agency. This state-funded group works to attain healthy air quality and protect the public from exposure to toxic air contaminants. CARB establishes air quality standards and monitors air quality.

In April 2007, the California Air Resources Board (CARB), voted to implement new limits for formaldehyde emitted from composite wood products. The regulation establishes the toughest production standard in the world for formaldehyde emissions from composite wood products.

The regulation applies to hardwood plywood, particleboard, medium density fiberboard (MDF) and all products (furniture, cabinets, flooring, store fixtures, millwork, countertops, doors, etc.) made with those products.

The CARB measure focuses on Formaldehyde, which is an organic compound that exists naturally in food, the environment, and our bodies. Formaldehyde is a common ingredient found in adhesives used in composite wood products, as it cross-links with other ingredients to form a strong bond. The regulation limits the amount of emissions of this compound to levels which the state deems to be safe.

While this law applies only to furniture consumed in the state of California, <u>all</u> Fairfield products meet CARB Phase II limits and are labeled to satisfy the California law.

Carton Charge

Merchandise will be cartoned upon request for an additional charge of \$24.00 per Ottoman, Bench or Chair and \$43.00 per Chaise, Sofa, Loveseat or Headboard.

Casters

Casters are available on specific frames as noted in the catalog for an additional charge of \$73.00. If an item is ordered with no nails, the windsor antique brass caster will be the standard caster, unless otherwise specified. The polished nickel caster is available at no additional charge, if the caster is standard. A polished nickel caster will be the default caster on any item ordered with nickel nails. A windsor antique brass caster will be the default caster on any item that is ordered with brass or pewter nails. Please <u>clearly</u> mark all purchase orders with your choice of caster finish. **Casters are not recommended for wood floors.**

Cleaning Codes (Fabrics)

- **S**..... Only mild, pure water-free dry cleaning solvents may be used.
- W..... Water-based cleaning agents or foam may be used.
- **WS** Water-based cleaning agents and foam may be used, may also be cleaned with mild, water-free solvents.
- X..... Should be vacuumed or brushed lightly to remove soil.

Combination of Fabrics (Inside/Outside Applications)

Combination of fabrics (Inside Outside Applications) is available on ottomans, chairs, loveseats, and sofas. If two Fairfield fabrics are used, including graded-in fabrics, the merchandise will be priced at the higher-grade price plus a \$31 charge. If the grades are the same, a \$31 charge will be added. An additional \$31 charge will be added to the frame for each additional fabric applied. For a frame requiring more than two fabrics, please provide a diagram with your order indicating fabric placement for each pattern. (See CONTRASTING PILLOW, CONTRASTING WELT CORD and DECORATIVE FRINGE paragraphs for additional information relating to pricing those items.)

Combination of Leathers (Inside/Outside Applications)

Combination of leathers (Inside Outside Applications) is available on ottomans, chairs, loveseats, and sofas. If two Fairfield leathers are used, the merchandise will be priced at the higher-grade price plus a \$31 charge. If the grades are the same, a \$31 charge will be added. An additional \$31 charge will be added to the frame for each additional leather applied. For a frame requiring more than two leathers, please provide a diagram with your order indicating leather placement for each pattern. (See CONTRASTING PILLOW, CONTRASTING WELT CORD and DECORATIVE FRINGE paragraphs for additional information relating to pricing those items.)

Combination of Leather & Fabric

Combination of leather and fabric is available on tight seat fabric chairs. Tight seat fabric chairs may have a leather (grade1 – grade 6) substituted for the fabric **on the seat** by adding \$245 to the fabric grade price.* Please specify the leather number and color of the leather you want applied to the seat. *A leather from grade 8 may be substituted by adding \$428.

If you desire to apply a combination of leather and fabric on other types of chairs (other than a tight seat), recliners, sofas, loveseats, settees, and ottomans, you can do so as follows. Please use the leather price and reduce that price by \$306 on sofas and loveseats, \$230 on chairs, recliners, and settees and \$153 on an ottoman. Please specify the fabric number and color and provide specific instructions as to where the fabric substitution is to be applied.

If you want nail-head trim added to the frame, please see the specific upcharge for the frame in the price list. When ordering, designate by adding an "N" to the suffix of the frame. Nail-head will not otherwise be added to a leather seat unless nail-head trim is standard, in some way, on that specific item in the price list.

NOTE: Depending on the size availability of leather hides, there is a possibility that areas of a frame may be pieced. Pieced areas, aiming for a minimum number of pieces, will be at the discretion of the factory.

For Graded-In Program fabrics above a grade U, use the following formula: (# above U) times 1.70 plus \$92, per pillow (please see page 15 for an explanation of our Graded-In Program).

(Note: Contrasting pillows are not to be confused with extra pillows which are priced on pages 36-39) of the current price list. Some frames ordered in leather/vinyl will <u>not</u> come standard with pillows. Please see your catalog or price list to see if pillows are standard with leather/vinyl application.)

Cushions - Loose Seat



ULTRA PLUSH 5L CUSHION - This five-layered cushion uses a soft grade of 2.0 lb. HR foam for the cushion core. The foam core is then capped with a 1-3/4" thick, soft convoluted foam on each side and wrapped with a 1-1/4 ounce fiber crown. The cushion is then encased in a white non-woven ticking. This combination of foams and fiber is designed to create a soft plush cushion yet will still maintain positive "memory" of its original shape. This cushion is standard on most Sofas and Lounge Chairs.

Exceptions to the above standard are the following frames which are standard with 5L Poly Dac (see below for description): 1072-01, 1080-01, 5118-01, 5125-01, 5129-01

BLEND DOWN CUSHION - This seat cushion is standard on certain frames where the "sit" calls for a luxurious, super soft feel. This premium seat cushion is constructed with a 2.0 density HR foam core which is surrounded by a combination of 50% polyester fiber, 45% duck feather and 5% duck down. The cushion is encased in a heavy down-proof ticking material. The feather and down fill have been cleaned using biodegradable emulsifiers. The result is a debris free, hypo-allergenic, natural fill with exceptional performance and a luxurious feel. **The Blend Down seat cushion is only available on the frames listed below. Therefore, it is not available as** an optional upgrade. See our superior "Spring Down Cushion", which can be ordered as an optional cushion upgrade.

Certain frames that feature a loose or a semi-attached back pillow may have the option to upgrade to a Blend Down back pillow (see frame number for upcharge information on Blend Down back pillows). Blend Down back pillows are constructed of a combination of 50% polyester fiber, 45% duck feather and 5% duck down and are encased in a heavy down-proof ticking material, which consist of locked channels that are sewn together in sections to keep the pillow from settling in one place. Regular "fluffing" of Blend Down pillows is recommended to keep them looking plump and full. The suffix used for Blend Down Back Pillows Only is option "O" (please see page 18 for additional suffix designations).

The following frames feature areas that are <u>standard</u> with Blend Down: 1416-01 (seat), 1416-20 (seat), 2601-01 (seat and back), 2601-25 (seat and back), 2729-01 (seat), 2729-31 (seat), 2729-32 (seat), 2729-50 (seat and throw pillows), 5267-01 (seat), 5267-20 (seat), 5422-01 (seat) and 6066-01 (seat).

DUAL ZONE CUSHION - Fairfield's Dual Zone premium seat cushion is uniquely constructed with two zones and five layers to provide the ultimate in support and comfort. The foundation of the Dual Zone cushion is made of a 2.3 Density Ultracel[™] HR foam core, which is divided into two zones – the front 1/3 is softer (23 IFD) and the rear two thirds is firmer (34 IFD). This provides more support in the rear to improve bone and body fatigue, and less pressure in the front for improved blood circulation in the legs. A softer layer of 1.8 Density, 18 IFD foam is applied over the top of the inner core to provide extra loft (crown) to the cushion. The outer layer is constructed of a Super Soft Foam. This 1.8 density Super Soft Foam offers the crush-resistance of foam with the loft, softness and conformity of fiber. It offers longer lasting height retention for good looks that last longer. All loose seat cushions can be upgraded to the Dual Zone premium cushion for \$46/cushion.



Cushions - Loose Seat (continued)

SPRING DOWN CUSHION - This premium seat cushion combines the soft, luxurious feel of Blend Down with the superior support and resiliency of individually pocketed coil springs. **Spring Down cushion is available as an option on any frame with a loose seat cushion.** The Spring Down cushion is constructed like the Blend Down cushion, except that the interior support of the cushion consists of individually pocketed, 3-inch high coil springs made of 15-gauge wire. The coil unit is surrounded by 2.0 density, 22 IFD foam with one ounce polyester fiber, top and bottom, and encased in a heavy down-proof ticking with a 50/50 mix of fiber/ down. The result is the luxury and softness of Blend Down with the resiliency and support of coil springs, making this superior cushion the ultimate in luxury seating. Spring Down is <u>not</u> available on ottomans.

When selecting a Spring Down seat cushion for frames which feature a loose or semi-attached back pillow and/or throw pillows, the back and/or throw pillows are available in Blend Down as an **option** (see description) of Blend Down pillows in previous section under "Blend Down Cushion"). Blend Down back and throw pillows do <u>not</u> automatically come with Spring Down seat cushions; you must specify them separately and add the appropriate upcharge for each (see frame number for upcharge information on all cushions and pillows).

The suffix used for Spring Down Cushion (Seat Only) is option "V". The suffix used for Spring Down Seat, Cushion in combination with Blend Down Back Pillow and/or Throw Pillows is option "W" (please see page 18 for additional suffix designations).



SUPPORT PLUS 3L SEAT CUSHIONS are available on all frames with loose seat cushions. See current price list for pricing.

This is an "all foam" cushion (no fiber crown) constructed with three layers of Premium HR foam. The core foam is a firm compression which is wrapped on each side with a layer of medium compression foam. This cushion is then encased in a white non-woven ticking. The outer layer provides a softer initial feel, while the inner core provides the firm support. This Premium "all foam" cushion is designed for high shape retention and will resist fatigue and sagging. It is especially recommended for use in Commercial/Contract applications.

3L POLY DAC - A 2.0 density HR (high resiliency) foam ("POLY") wrapped with 0.75 ounce low-melt polyester ("DAC") on each side.

5L POLY DAC - A 2.0 density HR (high resiliency) foam ("POLY") wrapped with a softer foam "crown patch" and 0.75 ounce low-melt polyester ("DAC") on each side.

Customer's Own Material (C.O.M.) and Customer's Own Leather (C.O.L.) (continued)

All C.O.M. orders will be priced at the "H" Grade price. All C.O.L. orders will be priced at the "K" Grade price. If more than one fabric is to be applied per frame, there will be an additional charge of **\$31** per fabric. **For stripes, plaids and matching designs, please refer to the chart on page 8 for yardage requirements.** This applies only to 54" wide fabric. Patterns less than 54" wide will require additional yardage. Yardage figures do not include optional items (arm covers, self-deck, etc.). All fabric must be first quality upholstery material. Fairfield reserves the right to reject any material that does not meet our standards. We will not be **responsible for defective fabric. Any special instructions <u>must</u> accompany the C.O.M. form or the fabric will be cut at the factory's discretion.** Please note that all stripes will be applied vertically, unless otherwise indicated. We reserve the right to determine if a C.O.M. pattern layout fits our cutting procedures. All fabrics must be properly identified with your company name, the frame number you are ordering and the PO number. **Proper identification of C.O.M./C.O.L. is imperative.** If we are unable to identify a C.O.M/C.O.L., or the **required amount** of the fabric is not received, the order cannot be processed and the anticipated ship date will be delayed. Please make sure C.O.M./C.O.L. is marked with your company name, PO number and the frame number you are ordering. See price list for C.O.M. yardage requirements. Please contact the factory for C.O.L. yardage requirements.

Flammability: It is the responsibility of the customer to advise Fairfield Chair Company of local fire code requirements for final shipping destinations at the time of order placement. All Fairfield Chair upholstered products meet or exceed the requirements of the California Technical Bulletin 117-2013, NFPA 260A-86 and Upholstered Furniture Action Council (UFAC) for flammability when upholstered with textiles that meet or exceed the same flammability requirements. Proof of COM/COL flammability compliance must be provided at the time of order placement.

NOTE: Fabrics with more than 40% silk content will not be accepted. ALL FABRICS CONTAINING SILK, OR SILK-LIKE FABRICS, MUST HAVE A KNIT BACKING. No silk, or silk-like, fabrics will be entered into production without a knit backing.

NOTE: Some heavy vinyls cannot be made into double welt.

Unbalanced Stripes: If a customer chooses any fabric with an unbalanced stripe, they need to be aware that the following areas may not match: inside backs, outside backs, inside arms, outside arms and arm panels. Per Fairfield manufacturing standards, stripes will be aligned as closely as possible. Please see image on right for an example of an unbalanced stripe when applied to a frame.

GAS UNIT MECHANISM is available on all office chairs, excluding "Essentials", for an additional charge of \$92.

KNEE TILT MECHANISM (Includes Gas Lift) is available on all office chairs for an additional charge of \$153.

Flammability Codes

CAL TB 117-2013 - California Technical Bulletin 117-2013 is a mandatory flammability standard for component materials used to make residential upholstered furniture which is to be sold in the state of California. All component materials used by Fairfield to manufacture its line of furniture meets California Technical Bulletin 117-2013. The exception to this is Customer's Own Material (COM), which may or may not meet CA TB 117-2013. All fabrics in Fairfield's own line meet CA TB 117-2013.

Additionally, all component materials used by Fairfield to manufacture its line of furniture contain no added flame retardant chemicals. Again, the exception to this is COM, which may or may not contain added flame retardants. No fabrics in Fairfield's own line contain added flame retardants.

If you are using COM, please, check with your fabric supplier if you are concerned with meeting CA TB 117-2013 or added flame retardants.

CAL TB 133 (California Bureau of Home Furnishings Technical Bulletin 133) - is a full-scale fire code that consists of six different tests to measure flammability. The test must measure the entire piece of upholstered furniture, consisting of frame, foam, fire resistant interliner, thread and fabric. Fairfield uses an "active" interliner under the fabric for all TB-133 certified items that actually assists in extinguishing a fire. Please see individual frames in the price list for TB 133 pricing.

UFAC (Upholstered Furniture Action Council) - The Upholstered Furniture Action Council was founded to make upholstered furniture more resistant to ignition from smoldering cigarettes, which are the leading cause of upholstery fires in the home. Household fires from smoldering ignition have been reduced substantially since its inception.

Fairfield Chair Company annually tests all components in its upholstered furniture, with the exception of COM fabrics. These tests certify compliance with the requirements of UFAC.

Moisture Barrier

SEAT - A plain Moisture Barrier fabric is available for all seat types and is constructed of a 210 thread count nylon fabric with a polyurethane coating designed to protect the foam and cushioning from penetration of liquids. This fabric is anti-bacterial, anti-fungal, mildew resistant and meets CAL 117-2013 requirements. When applying to a frame with a tight seat, the moisture barrier fabric will be applied directly under the chosen fabric. If the frame has a loose seat cushion, the cushion will be wrapped with the moisture barrier fabric and then upholstered with the chosen fabric.

DECK - A plain Moisture Barrier Decking is available for all loose seat frames. This beige decking is constructed of a 100% double-knit polyester that has been treated with an oven-dried, multiple step process designed to impart water repellency, stain repellency and anti-microbial properties.

Non-Breathing Fabrics

Items that feature a loose seat cushion, when ordered in Vinyl, Cryptons and other fabrics that do not breathe (excluding leather), will have vented grommets applied to the backside of the cushion positioned above and below the zipper. These grommets allow for a gradual transference of air to pass through when weight is applied to the cushion. The cushion is, therefore, reversible.

Optional Breathable Denim Panel: For a faster transference of air, cushions may be upholstered with an optional fabric panel sewn to the bottom of the cushion. The fabric panel is made of a denim material which allows for air to transfer through the cushion more efficiently than the vented grommets. This mimics how we upholster leather cushions. Cushions upholstered this way are not reversible. The upcharges for this option are: Chair - \$37; Chaise - \$77; Loveseat/Settee - \$37 per cushion; Sofa - \$37 per cushion; Bench Seat Loveseat/Settee/Sofa - \$77.

Care of Wood Finishes

For day to day maintenance, regular dusting with a dry soft cloth is recommended.

Cleaning requires only wiping with a clean, damp cloth and then drying. To remove general soil, the coated surface may be wiped clean with a fresh solution of mild soap (ie, Murphy's Oil Soap; mix as directed) and water. The cloth should be soft and dampened with the soap solution. The surface should then be wiped down with a clean dry, soft cloth to remove excess moisture. It is important to ensure that the surface is dried. Always wipe in the direction of the wood grain.

Other "wood cleaning" products exist but may contain alkaline reagents or other ingredients which may damage the coated surface. Over time these materials can soften the finish potentially leading to film failure. The softening may also lead to incidental damage from environmental influences such as water or moisture damage, increased susceptibility to scratching or abrasion, and staining.

Household polishes that are wax free and silicone free can be used on an infrequent basis (we recommend Guardsman Furniture Polish).

Points to remember:

Routine cleaning will prevent long term damage from dirt and grease which will form a film over time, dulling and discoloring the finish. Using anything other than a mild soap solution and then drying the surface with a soft cloth may damage the finish.

Where possible, keep finish away from exposure to direct sun. Over time sunlight may change the color of the finish, and/or damage the finish.

Avoid extremes in temperature or moisture as they can cause wood to expand or contract leading to potential coating damage.

Construction of Wood Product

All occasional products manufactured by Fairfield Chair are built using the most trusted construction techniques that have been in practice for centuries. Ensuring the integrity of a piece of furniture is the number one priority in furniture construction. Therefore, we insist on holding to the furniture standards established through years of handcrafted furniture experience. Wood is a natural product which reacts to the environment and these furniture standards will allow the product to react without compromising the longevity.

The interior construction of a piece of wood furniture often plays a more important role in its longevity than its beautifully finished or natural exterior wood. Fairfield's wood furniture construction uses a combination of solid hardwoods, plies and engineered wood. These parts are machined using Joinery techniques such as Mortise and Tenon joints, Dowel Joints and Dovetail joinery. While the design may demand a different type of joinery, all of our tops are constructed using veneer and engineered substrate (core) materials. This construction falls under the Plies and engineered wood application which allows beautiful veneers to be used on tops that will not move or transfer reaction to the environment into the tops.

We consider these manufacturing applications to be critical to our success. Wood furniture construction is both an art and a science. The beauty achieved through elaborate finishing techniques coupled with today's advanced manufacturing techniques results in wood furniture that is not only very attractive, but sturdy and durable, too. Quality wood furniture, such as that you'll find here at Fairfield Chair, may last several lifetimes.

- 1A Seat cushion (top and bottom panels) line or spot with inside backs (front and back panels).
- 1B Spot fabric Spot centers on backs or back pillow, seats, skirts and outside arms, but do not stack (double expose) pattern as same spot on center of cushion, cushion border, and platform plus skirt panel.
- 2A Top borders and tacking borders on loose back pillow will line with the seat cushion.
- 2B The side of the back tacking border will not line on semi-attached seats or backs.
- 3 Back and seat cushions line horizontally. (We do not flow match- we spot fabrics).
- 4A Inside arms will front on the same stripe except on unbalanced stripes and plaids. When the pattern is primary and the stripe is secondary, the pattern controls and centers the inside arm.
- 4B Outside arm will line with inside arm. The inside arm controls, unless unbalanced stripe with nap.
- 4C Arm panels spot/stripe on the same spot/stripe as cushion and backs.
- 4D Outside arms and wings center on the same stripe. (The inside wing controls).
- 4E Outside wing lines with outside arm.
- 4F Inside arms and inside wings will line.
- 5A Outside backs will line vertically with inside backs on all chairs and tight back sofas and loveseats. Curved back sofas, loveseats, and chairs will line in center only.
- 5B Piece-outs on the inside of tight back sofas and loveseats are to fill-out the pattern (includes stripes, prints, and plains with a pattern or design). Outside back patterns will also fill-out, except on contoured frames.
- 5C Plaids or horizontal stripes on the outside back and outside arms will bottom the same.
- 5D **Inside arms** and outside arms will bottom the same when sewn together. Outside arms and outside backs will bottom the same when sewn together.
- 6 The outside back of loose backs and semi-attached back sofas will line only with the center cushion.
- 7 All skirt panels will line vertically and horizontally on all four sides.
- 8 Knife-edge cushions line around top and bottom when the stripe dominates. If the spot dominates, the bottom of the cushion spots like the top.
- 9A Ottomans will be pieced on all four corners such that the sides will also line up.
- 9B Ottoman top lines with border, platform and skirt on front and back only.
- 9C Ottoman skirts line on all four sides with the platform and border.
- 10A Welts line across the front; that is across the skirts, front of the cushion borders, top of back pillows, and also the middle of the outside back welt.
- 10B Welt is not pieced in highly visible areas.
- 11 Front of inside arms and back side where pleats are required must have the same quantity and size pleats on each side.

FAIRFIELD LIFETIME LIMITED WARRANTY INFORMATION - RESIDENTIAL

Fairfield warrants its merchandise to be free of defects in materials and workmanship for the life of the piece under normal residential use and conditions to the original purchaser. Exceptions to this warranty include:

- Commercial/Contract use (see separate warranty)
- Fabrics One (1) year
- Customer's Own Material (COM) Not warranted
- Standard Executive Swivel Bases and Mechanisms – Five (5) years
- Knee Tilt and Gas Lift Mechanisms Five (5) years
- Casters Five (5) years
- Glides Not Warranted
- Recliner Mechanisms (non-motorized) Three (3) years
- Recliner Mechanisms (motorized) One (1) year
- Swivel, Swivel Rocker and Swivel Glider Mechanisms Three (3) years
- Sleeper Mechanisms Three (3) years
- Innerspring Sleeper Mattresses Five (5) years
- Renting, recovering, misuse or abuse
- Damage due to carrier or customer handling
- Case Goods One (1) year

Fabrics will naturally stretch and wear with normal use and is not considered evidence of defectiveness. Fabric fading, piling, heavily soiled, improperly cleaned and "after-market" chemically treated fabrics are not covered by this warranty. Customer's Own Material (COM) is not warranted.

Seat cushion cores have a lifetime warranty against loss of resiliency. Through normal use, all cushion cores will soften and lose loft with time. Loose seat cushions and back pillows should be fluffed and turned weekly. Polyester fibers will lose loft with normal use and is not to be considered defective.

Warranty service is handled through the original furniture agent/dealer. Should service be needed, contact your furniture agent/dealer. After receiving Fairfield authorization, the agent/dealer will either repair or return the defective item to the factory for repair or replacement. Fairfield's responsibility for transportation and labor is limited to one year from the original purchase date and to the transportation between the agent/dealer's location and the factory. Outside the USA, warranty is limited to replacement parts only.

Full grain aniline with the luster of an antiqued leather

1084 Leather (Grade 6)

Semi aniline dyed top grain leather with a wax and oil finish. A slightly protected leather that allows the migration of natural markings.

1090 Leather (Grade 3)

A soft handed semi aniline with a protective finish to assure carefree use

1093 Leather (Grade 5)

Full grain vegetable dyed leather. Vegetable tanning, or veg-tan, is an age-old process of using deep, richly colored vegetable dyes to add depth of color to the leather hides.

1105 Leather (Grade 5)

This leather is an aniline dyed, slightly corrected leather that has been excessively tumbled to create a very supple hand. The coloration and feel of this leather are that of a leather normally used for clothing.

1108 Leather (Grade 5)

A top grain leather with a hand padded application to create an antiqued look. The hand padding also adds some protection to the leather.

1115 Leather (Grade 5)

A top grain leather with a very soft hand and lightly applied hand rubbed sauvage to create an antique look and add durability.

1121 Leather (Grade 8)

This leather is a natural top grain tanned with the hair left on the hide, thus referred to as a hair-on-hide. These leathers are mainly used as accent leathers, but can be used all over on a piece of furniture. Please note that these are all natural hide, color variation and design variation should be expected.

1128 Leather (Grade 4)

A top grain leather with a raised grain or pebbled effect to the surface. The colors are bright and clear because of the use of pigments in the finishing process. This is a great leather for use in a contemporary or transitional setting.

1141 Leather (Grade 4)

Tanned on full grain buffalo hides, this leather is milled and finished with a soft wax treatment for a casual traditional look.

1142 Leather (Grade 4)

A top grain leather inspired by eclectic lifestyle with upbeat color and a supple feel.

1145 Leather (Grade 5)

A full aniline, hand rubbed traditional leather in luxurious earth tone colors. The soft hand makes it ideal for a variety of applications.

1146 Leather (Grade 3)

A pigmented leather providing consistency of color, with a subtle two tone effect for a natural look. A clear finish top coat is added for protection.

1147 Leather (Grade 8)

This leather hide is embossed with a large crocodile grain and then colored by applying pigments which are then "wiped-off" to give contrast and highlights. It is lightly protected with a topcoat providing great depth and warmth to the finished product.

1149 Leather (Grade 5)

A full grain aniline dyed leather. It is hand antiqued for a natural look and is finished with a top coat for protection.

1151 Leather (Grade 5)

This leather features corrected grain that has been finished with a pigmented topcoat and then embossed with an artificial grain pattern. The result is a leather offering excellent value and fantastic durability.

1155 Leather (Grade 2)

This is a top grain leather that has been slightly buffed and corrected to create an even, consistent surface. Extended milling accentuates the natural grain of this leather as well as its inherent softness.

1156 Leather (Grade 4)

This is a semi aniline dyed with a protective top coat. It has a soft, flat surface that is smooth and supple The colors available complement todays styling.

1157 Leather (Grade 5)

This is a semi-aniline leather with luxurious feel and deep luster. The surface is hand antiqued adding depth of color and enhancing the natural leather characteristics.
