RE: ADVERTISEMENT FOR BIDS FOR GENERAL SUPPLIES, FOR FEEDING OF PRISONERS, COUNTY DEPOSITORIES, PEST CONTROL SERVICES, JANITORIAL SERVICES, ETC.

WHEREAS, Walthall County, Mississippi, has need to purchase supplies for use and maintenance of roads and bridges of Walthall County, Mississippi, and other services for the period of time from January, 2020 through December, 2021, and

WHEREAS, it would be in the best interest of Walthall County, Mississippi and its people that advertisement be made for the purchase of said supplies and services.

IT IS THEREFORE, ORDERED AND RESOLVED that the Clerk of this Board be authorized and directed to cause to be published in the *Tylertown Times*, in the manner provided by law, the following notice, to-wit:

ADVERTISEMENT FOR BIDS

The Walthall County, Mississippi Board of Supervisors will receive sealed bids until 10:00

o'clock A.M., on Monday, December 2, 2019, and will open such bids as soon thereafter as

conveniently possible for general supplies and culverts as herein below mentioned and other

services:

For the period of time from January, 2020 through December, 2020, said materials, supplies and

services being generally defined and described as follows, to-wit:

GENERAL SUPPLIES, ETC.:

(1) Oil, grease, gasoline, diesel, fuels and oils necessary to the operation of the road machinery and trucks of the county. SERVICES:

(1) Feeding of prisoners, including prisoners with special diets, housed in the Walthall County, Mississippi Jail, for a period of TWELVE MONTHS from the first meal on the First Wednesday after the First Monday of January, 2020, including Sundays and all Holidays. Bids should be submitted on a per meal basis.

(2) Pest control services for a period of time from January 1, 2020 until the First Monday in January, 2021.
