### **Project Details**

- 1. Describe the commodity/service that the agency/institution is seeking to procure:

  Accurint is an industry leader in the responsible use of data and protection of individual privacy. Accurint, using public records and non-public information, provides invaluable information of the Jackson Heart Study participants who we have lost contact for some time.
- 2. Explain why the commodity/service is the only one (1) that can meet the needs of the agency/institution:

Jackson Heart Study staff contacts the participants every year with the information provided. For some participants the contact is no longer valid since they may have moved for that address, changed phone numbers. In order get in touch the participants we use different sources to get their contact information. One source is Accurint.

LexisNexis is the leading company in identifying the participants addresses and other contacts. The same product is being used by other studies like ARIC and would to be consistent in finding the information. It gives instant access to a comprehensive database of public records, up to date phone numbers.
