Regarding UMMC Sole Source Certification Number **SS9107** for **IT Service for Epic Healthy Planet**, please be advised that UMMC intends to award the purchase of the **IT Service for Epic Healthy Planet** to **Hattiesburg Clinic** as the sole source provider of the IT services.

UMMC issues this notice in accordance with Mississippi state law, policy, and procedures for sole source procurements.

Sole Source Criteria

1. Where the compatibility of equipment, accessories, or replacement parts is the paramount consideration (and manufacturer is the sole supplier).
2. Where a sole supplier's item is needed for trial use or testing.
3. Where a sole supplier's item is to be required when no other item will service the needs of UMMC.

Project Details

1. Describe the commodity/service that the agency/institution is seeking to procure:

Hattiesburg Clinic has a highly customized programming and workflow build of the Epic Healthy Planet Module. This is proprietary coding and knowledge developed and implemented by Hattiesburg Clinic.

2. Explain why the commodity/service is the only one (1) that can meet the needs of the agency/institution:

Hattiesburg Clinic's customization of Epic's Healthy Planet Module and other clinical workflows to aid in addressing the challenges of providing clinical services and managing certain patient populations. The coding and programmatic workflows within the Epic Electronic Medical Record is proprietary knowledge developed by Hattiesburg Clinic.

3. Explain why the source is the only person or entity that can provide the required commodity/service:

The coding and programmatic workflows within the application is proprietary knowledge developed by Hattiesburg Clinic. These services may only be purchased directly from Hattiesburg.

This is not available from any other distributor. See supporting letter from **Hattiesburg Clinic**, Attachment A.

4. Explain why the amount to be expended for the commodity/service is reasonable:

The estimated amount to be expended is for the purchase of these service is \$225,000.00. Total investment to-date will be **\$225,000.00**. This amount is within the expected price range for these products.

5. Describe the efforts that the agency/institution went through to obtain the best possible price for the commodity/service:

UMMC was able to negotiate this price with the vendor.
