The City of New Albany of Union County, Mississippi, will receive bids for the **New Albany Trails**, Federal Project No. **STP-0350-00(013)LPA/106411-701000** no later than 10:00 A.M., Local Time, on the 6th day of November, 2014, at the Board Room located at 101 W. Bankhead Street, New Albany, MS 38652. All bids so received will be publicly opened and read aloud.

The work shall consist essentially of the following items:

Expand the existing trail system and upgrade the existing 5 foot section to 10 feet.

The above ground outline of features of the work does not in any way limit the responsibility of the Contractor to perform all work and furnish all plant, labor, equipment and materials required by the specifications and the drawings referred to therein.

The attention of bidders is directed to the Contract Provision governing selection and employment of labor. Minimum wage rates for Federal Aid Projects have been predetermined by the Secretary of Labor and are subject to Public Law 87-581 , Work Hours Act of 1962, as set forth on the Contract Provisions.

The City of New Albany hereby notifies all Bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, disadvantaged and women's business enterprises will be afforded the full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award.

The award of this contract will be contingent upon the Contractor satisfying the DBE/WBE requirements.

Each bid shall be accompanied by a Certified Check on a solvent bank or a Bidder's Bond issued by Surety Company licensed to operate in the State of Mississippi, in the amount of five percent (5%) of the total bid price, payable to the City of New Albany as bid security. Bidders shall also submit a current financial statement, if requested by the City. The successful bidder will be required to furnish a Performance Bond and a Payment bond each in the amount of one hundred percent (100%) of the contract amount.

The proposal and contract documents in its entirety shall be submitted in a sealed envelope and deposited with the City Clerk, prior to the hour and date above designated. No bidder may withdraw his bid within sixty (60) days after the date of actual bid opening, without the Owner's consent.

Work to be performed shall be in accordance with the "Mississippi State Highway Standards Specifications for Road and Bridge Construction, 2004", together with all amendments and/or special provisions and/or addenda to the standards duly approved and adopted, unless otherwise noted in these specifications.

The attention of Bidders is directed to the provisions of Subsection 102.07 pertaining to irregular proposals and rejection of bids.
