

ADVERTISEMENT FOR BIDS

Separate and sealed Bids for the project entitled **“Repair and Repaint Elevated Water Storage Tank at North Lee Industrial Complex”** will be received by the Northeast Mississippi Regional Water Supply District at the office of the Engineer, Cook Coggin Engineers, Inc., located at 703 Crossover Road, Tupelo, MS 38801, until 10:00 AM local time, Friday, September 19, 2014, and then at said office publicly opened and read aloud.

The work site is located at the North Lee Industrial Complex, at the intersection of Southwest Ave. and Mitchell Ave., west of U.S. Hwy. 45 near Baldwyn in Lee County, MS. The project consists of making miscellaneous internal repairs and modifications, interior cleaning, interior repainting, and installation of external conduit and wiring for a 500,000 gallon elevated steel water storage tank. The project also includes disinfection and all additional work required to return the tank to service.

The Contract Documents may be examined at the Northeast Mississippi Regional Water Supply District, 113 Clark Street, Suite 3, Tupelo, MS 38804 and at the office of the Engineer, Cook Coggin Engineers, Inc., 703 Crossover Road, P. O. Box 1526, Tupelo, Mississippi 38801.

Bid Documents are being made available via original paper copy. Prospective plan holders are required to register for an account at www.cceplanroom.com in order to view or obtain Bid Documents. A valid email address is required for registration. The cost of the Bid Documents is \$100.00 and they must be purchased through the website. The charge for Bid Documents is non-refundable. Questions regarding website registration and online orders shall be directed to Plan House Printing at (662) 407-0193.

Bids will be accepted only under the name of the Bidder to whom contract documents have been issued by the Engineer. Bids shall be submitted in the manner prescribed in the “Information for Bidders” section of the Contract Documents. Each Bidder must deposit with the Bid a Bid Bond or security in the amount, form and subject to the conditions provided in the “Information for Bidders”. No Bidder may withdraw his Bid within 90 days after the actual date of the Bid opening.

All applicable laws, ordinances and the rules and regulations of all authorities having jurisdiction over construction of the project shall apply to the contract throughout. Each Bidder is responsible for inspecting the site and for reading and being thoroughly familiar with the Contract Documents. The failure or omission of any Bidder to do any of the foregoing shall in no way relieve any Bidder from any obligation in respect to this Bid.

The Contract will be awarded as an entire job and no items will be let for separate work. A conditional or qualified Bid will not be accepted. If awarded, the contract award will be made to the lowest responsible, responsive Bidder. The Owner reserves the right to waive any informality or to reject any or all Bids.
